Lots 1, 3, 4, 5, 6 and 7, in Starwood South, a Subdivision in Douglas County, Nebraska, EXCEPT that part of said Lot 4 dedicated for street purposes described as follows:

Commencing at the Northeast corner of said Lot 4; thence  $N57^{\circ}14'06''W$  (assumed bearing), 18.41 feet, on the North line of said Lot 4, to the point of beginning; thence continuing  $N57^{\circ}14'06''W$ , 257.00 feet, on the North line of said Lot 4; thence Southwesterly on the Northwesterly line of said Lot 4, on a 25.00 foot radius curve to the left, chord bearing  $S77^{\circ}45'54''W$ , chord distance 35.36 feet, an arc distance of 39.27 feet; thence  $S32^{\circ}45'54''W$ , 13.81 feet, on the West line of said Lot 4; thence Southwesterly on the West line of said Lot 4, on a 228.92 foot radius curve to the left, chord bearing  $S30^{\circ}10'56''W$ , chord distance of 20.63 feet, an arc distance of 20.64 feet; thence Northeasterly on a 38.00 foot radius curve to the right, chord bearing  $N75^{\circ}10'56''E$ , chord distance 56.11 feet, an arc distance of 63.12 feet, to a point 18.00 feet South of the North line of said Lot 4; thence  $S57^{\circ}14'06''E$ , 74.22 feet on a line 18.00 feet South of and parallel with the North line of said Lot 4; thence  $S63^{\circ}18'53''E$ , 169.96 feet to the point of beginning, ALSO EXCEPTING THEREFROM that portion of Lot 1 dedicated for street purposes described as follows:

That part of Lot 1, Starwood South, a Subdivision in Douglas County, Nebraska, described as follows: Beginning at the Northwest corner of said Lot 1; thence  $S32^{\circ}45'54''W$  (assumed bearing) 230.00 feet on the Westerly line of said Lot 1; thence  $N40^{\circ}21'35''E$  90.80 feet to a point 12.00 feet Easterly of the Westerly line of said Lot 1; thence  $N32^{\circ}45'54''E$  140.00 feet on a line 12.00 feet Easterly of and parallel with the Westerly line of said Lot 1 to the Northerly line thereof; thence  $N57^{\circ}14'06''W$  12.00 feet on the Northerly line of said Lot 1 to the point of beginning.
