


"SWEDES INDUSTRIAL SITE"

SURVEYOR'S CERTIFICATE

I hereby certify that I have accurately surveyed and set iron pipes to monument all corners, angle points, and points of curvature within "SWEDES INDUSTRIAL SITE", which is a replat of part of Porter Place Addition, specifically:

- (a) The Westerly 56 5', more or less of lot 21,
- (b) Part of Sublot 3 of lot 25,
- (c) That part of fractional lot 25, lying Westerly from the Plattsmouth Industrial Site #2,
- (d) A fractional part of lot 8, Plattsmouth Industrial Site #2, described thus: commencing at the point of intersection of said lot 8, thence North, 114 08', to the West line (along the West line), thence East, 7 30', thence South, 114 08', to the South line of lot 8, thence West, 7 92', to the point of beginning containing 0.02 Acres
- (e) A fraction of lot 7, Plattsmouth Industrial Site #2, described thus: commencing at the point of intersection of said lot 7, thence South 152 89', along the North line of lot 21, thence South 152 89', to a point of curvature which is 8 37' East of the West line of lot 7, thence (following the arc of a 50' radius curve to the left, 70 41', to a point 68' Northwesterly from the SW corner of lot 8, (Industrial Site #2), thence S 88° 28' 20" E, 7 30', thence S 1° 34' 45" to the SW corner of lot 8, (Industrial Site #2), thence S 88° 28' 20" E, 7 30', thence S 1° 34' 45" to the NE corner of said lot 24, thence N 88° 28' 20" W, 166 30', thence N 1° 30' 58" E, 485 65', thence S 88° 28' 20" W, 166 00', to a point on the Easterly right-of-way of Lincoln Ave., thence N 25° 27' 35" E, 244 21', to the point of beginning.

We do further dedicate to the public, for public use, the roadway as shown, to be hereafter known as "WARRIOR DRIVE", (the width as indicated), and we further reserve the easements as follows:

- (a) A 20' wide easement being 10' each side of the centerline of the sanitary sewer main, which runs more or less along the line common to lots 8 & 9.
