### 3. Resolution

Board of Co. Commissioners

RESOLVED,

To Whom it may concern. Whereas, there was submitted to the Board of County Commissioners of Douglas County, Nebraska, on the 14th day of August, 1916, a petition signed by a majority of the voters living within two miles of the public road running north from the Southeast corner of Section 6, Township 14, Range 13, one-half mile to "L" Street in the County of Douglas and State of Nebraska, asking and requesting the Board of County Commissioners to vacate a strip eight feet wide on either side of the above described road.

AND WHEREAS, it appearing to the satisfaction of the Board of County Commissioners that a majority of the voters living within two miles of said road have signed said petition, and it further appearing to the Board that it is for the best interests of all concerned that the request of said petitioners be granted,

THEREFORE BE IT RESOLVED, by the Board of County Commissioners of said County that a strip eight feet wide on either side of said road running north, and beginning at the Southeast corner of Section 6, Township 14, Range 13, one-half mile to "L" Street in said County, be and the same hereby is vacated.

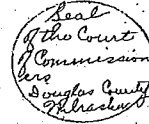

### 4. Land Contract.

John Pelter

&

Clinton Tyler.

THIS AGREEMENT, Made the 5th day of November, A. D. 1915, between John Pelter, party of the first part, and Clinton Tyler, party of the second part.
