

## EXHIBIT "A"

Those portions of Tax Lot 10 in the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section 4, Township 14 North, Range 13 East of the 6th P.M., in the City of Omaha, in Douglas County, Nebraska, more particularly described as follows, to-wit:

Commencing at a point where the West right-of-way line of 33rd Street, as it now exists, intersects with the North right-of-way line of "Q" Street, as it now exists; thence West, 502.5 feet, along the North right-of-way line of said "Q" Street, to the Point of Beginning; thence North, at a 90° angle, 281.69 feet, parallel to West right-of-way line of said 33rd Street; thence East, at a 90° angle, 352.5 feet, parallel to the North right-of-way line of "Q" Street; thence South, at a 90° angle, 281.69 feet, parallel to the West right-of-way line of said 33rd Street; thence West, at a 90° angle, 352.5 feet, to the Point of Beginning;

Beginning at a Point on West right-of-way line of 33rd Street, as it now exists, 281.69 feet North of intersection of West right-of-way line of said 33rd Street with the North right-of-way line of "Q" Street, as it now exists; thence West, 502.5 feet, parallel to the North right-of-way line of said "Q" Street; thence North, at a 90° angle, for a distance of 30 feet; thence East, 502.5 feet, parallel to the North right-of-way line of said "Q" Street, to the West right-of-way line of said 33rd Street; thence South, 30 feet, to the Place of Beginning;

AND.

Beginning at a point on the West right-of-way line of 33rd Street, as it now exists and intersects with the North right-of-way of "Q" Street, as it now exists; thence Westerly, 150 feet, along the North right-of-way line of "Q" Street; thence North, at a right angle, 150 feet, parallel to the West right-of-way line of 33rd Street; thence East, at right angle, 150 feet, parallel to the North right-of-way line of "Q" Street, to the West right-of-way line of 33rd Street; thence South, along the West right-of-way line of 33rd Street, to the Point of Beginning;

EXCEPTING therefrom the following described property (a corner severance which has been dedicated to the City of Omaha):

Beginning at the intersection of the Northerly right-of-way line of "Q" Street with the Westerly right-of-way line of 33rd Street; thence North, 20.00 feet; thence Southwesterly, to point on the Northerly right-of-way line of "Q" Street, and 25 feet Westerly of the point of beginning; thence Easterly, along the Northerly right-of-way line of "Q" Street, 25.00 feet, to the Point of Beginning.
