Beginning at the Northeast corner of said Lot 4, said point being 50.00 feet South of the North line of the Northeast Quarter of Section 8, Township 14 North, Range 11 East of the 6th P.M., in Douglas County, Nebraska, and 40.00 feet West of the centerline of 181st Plaza; thence on an assumed bearing of South 02°49'26" East, along the East line of said Lot 4, a distance of 72.00 feet, to a point; thence South 87°10'16" West, a distance of 3.00 feet, to a point; thence North 02°49'26" West, a distance of 50.10 feet, to a point; thence North 47°07'47" West, a distance of 22.22 feet, to a point; thence South 87°10'35" West, a distance of 241.90 feet, to a point on the West line of said Lot 4; thence North 01°41'13" West, along the West line of said Lot 4, a distance of 6.00 feet, to the Northwest corner of said Lot 4, said point being 50.00 feet South of the North line of said Northeast Quarter; thence North 87°10'34" East, along the North line of said Lot 4, said line being 50.00 feet South of and parallel with the North line of said Northeast Quarter, a distance of 260.30 feet, to the Point of Beginning;

Together with non-exclusive easement rights appurtenant thereto as established by the Plat and Dedication of 180th Plaza Replat Four recorded August 17, 2005, as Instrument No. 2005101498, and by Declaration of Covenants, Conditions, Restrictions and Easements for 180th Plaza dated May 20, 2004 and recorded May 27, 2004, as Instrument No. 2004068727, both of the Records of Douglas County, Nebraska.
