

DEED OF CORPORATION

KNOW ALL MEN BY THESE PRESENTS, that

MERCER REALTY COMPANY, a corporation organized and existing pursuant to and by virtue of the Laws of the State of Nebraska, (sometimes hereinafter referred to as "Grantor"),

by virtue of a Plan of Liquidation adopted in accordance with the provisions of the Nebraska Business Corporation Act does hereby grant and convey unto

FIRST NATIONAL BANK OF OMAHA, TRUSTEE  
(hereinafter referred to as "Grantee"),

an undivided 2.669 % interest in any and all real property in which the Grantor may have any interest whatsoever situated in Douglas County, Nebraska, including but not limited to, the realty described in Exhibit "A", attached hereto and by this reference incorporated as a part hereof.

To have and to hold such real property as is owned by the Grantor as aforesaid, together with all the tenements, hereditaments, and appurtenances thereunto belonging or in any wise appertaining, and all estate, right, title, interest, claim or demand whatsoever of the Grantor, either in law or in equity, either in possession or expectancy, of, in, and to said real property, but subject however to liens, encumbrances, and restrictions of record, some of which may be reflected in Exhibit "A".

It is the intent and purpose of this conveyance to transfer to the Grantee herein the aforesaid undivided interest in any and all real property owned by the Grantor situated in Douglas County, Nebraska, whether or not by inadvertence omitted from or inaccurately described in Exhibit "A".

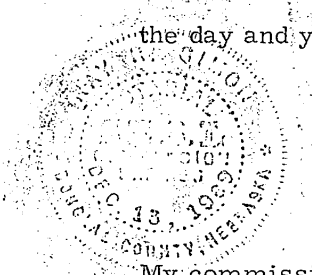

Lot Eight (8), Block Twelve (12), Original City of Omaha, as surveyed and lithographed.

Lots Five and Six (5 & 6), Block Fifty-Six (56), Original City of Omaha, as surveyed and lithographed.

Lot Eight (8), Block Ninety-One (91), Original City of Omaha, as surveyed and lithographed.

Lots Seven and Eight (7 & 8), Block One Hundred Fifty-One (151) Original City of Omaha, as surveyed and lithographed.

The North Ninety-Nine Feet (N 99') of Lot Four (4), Block One Hundred Sixty-Four (164), Original City of Omaha, as surveyed and lithographed.

The South Thirty-Three Feet (S 33') of Lot Four (4), Block One Hundred Sixty-Four (164), Original City of Omaha, as surveyed and lithographed.

The East Seventy Feet (E 70') of Lot Eight (8), Block One Hundred Fifty-Two (152), Original City of Omaha, as surveyed and lithographed.

The East Sixty-One and One-Half Feet (E 61-1/2') of the South One Hundred Thirty-Two Feet (S 132') of Sub Lot Nine (9), Lot Two (2) Capitol Addition, an addition to the City of Omaha, Douglas County, Nebraska.
