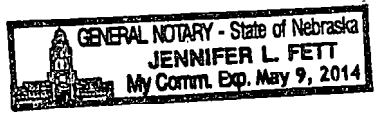

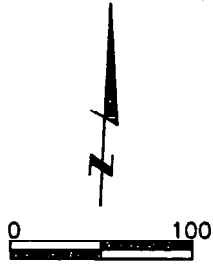
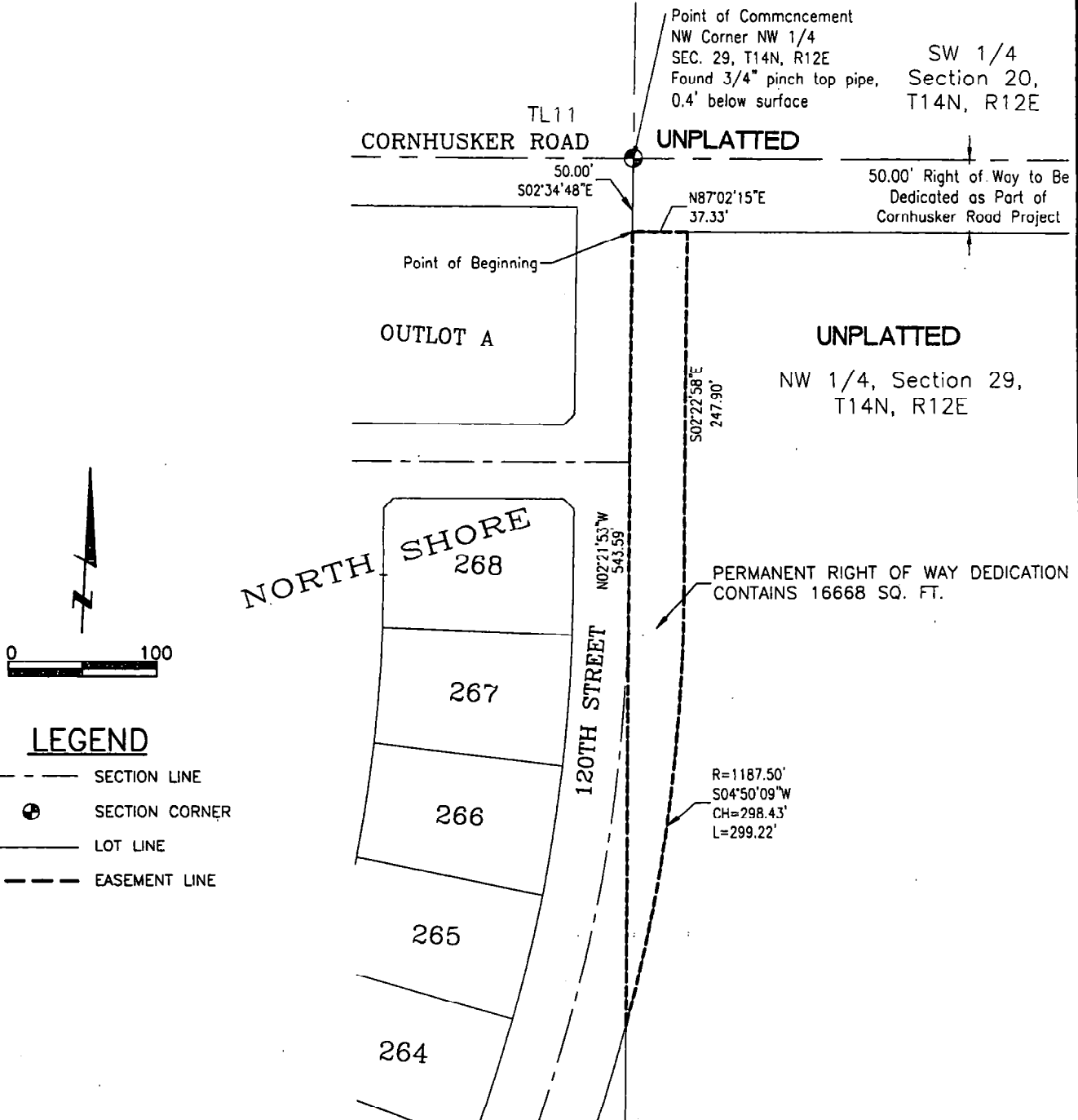

Legal Description

A permanent right of way dedication over that part of the Northwest Quarter of Section 29, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Commencing at the northwest corner of the Northwest Quarter of said Section 29;
Thence South $02^{\circ}34'48''$ East (bearings referenced to Nebraska State Plane NAD83-2008) for 50.00 feet along the west line of the Northwest Quarter of Said Section 29 to the proposed south right of way line of Cornhusker Road and the TRUE POINT OF BEGINNING;
Thence North $87^{\circ}02'15''$ East for 37.33 feet along said proposed south right of way line;
Thence South $02^{\circ}22'58''$ East for 247.90 feet;
Thence along a curve to the right (having a radius of 1187.50 feet and a long chord bearing South $04^{\circ}50'09''$ West for 298.43 feet) for an arc length of 299.22 feet to the west line of the Northwest Quarter of said Section 29;
Thence North $02^{\circ}21'53''$ West for 543.59 feet to the Point of Beginning.
Contains 16,668 square feet.
