

RESOLUTION

WHEREAS the County Board of Supervisors of Washington County, Nebraska, proposed amendments to the zoning regulations of Washington County, Nebraska, which proposed amendments were duly submitted to the Planning Commission of Washington County, Nebraska, for its recommendations, and

WHEREAS the Planning Commission of Washington County, Nebraska, has recommended the adoption of such proposed amendments, and

WHEREAS notice of hearing of such proposed amendments was duly given at least ten days prior to hearing as provided by law, and

WHEREAS public hearing was had thereon on the 22nd day of May, 1972.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Supervisors of Washington County, Nebraska, that the zoning regulations of Washington County, Nebraska, be amended as follows:

At Page 33 of the Washington County, Nebraska zoning regulations, add as a new paragraph at the end of the section covering "Exceptions" as follows: A special use permit may be granted for a period of one year for location of a mobile home on a farm for the purpose of providing a dwelling for persons whose vocation or employment is agricultural and is solely related to the land on which such mobile home is located. The location of such mobile home shall be within the area occupied by a farmstead on such farm.

At Page 32 of the Washington County zoning regulations in the paragraph covering "Application for Special Use Permits" change the number twenty five to fifty dollars.

At Page 32 of the Washington County zoning regulations add at the end of the section "Public Hearing" the following: In addition to the publication of the notice, as aforesaid, a notice

At Page 32 of the Washington County zoning regulations add at the end of the section "Public Hearing": the following: In addition to the publication of the notice, as aforesaid, a notice shall be posted in a conspicuous place on or near the property on which action is pending. Such posted notice shall be not less than eighteen inches in height and twenty four inches in width with a white or yellow background and black letters not less than one and one half inches in height. Such posted notice shall be so placed upon or near such premises that it is easily visible from the public street or road nearest the same and shall be so posted at least ten days prior to the date of such hearing. It shall be unlawful for any one to remove, mutilate, destroy or change such posted notice prior to such hearing and any person so doing shall be deemed guilty of a misdemeanor.

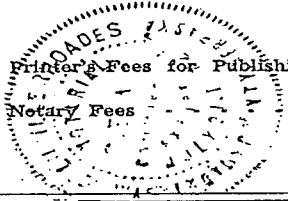

Such posted notice shall be not less than eighteen inches in height and twenty four inches in width with a white or yellow background and black letters not less than one and one half inches in height.
