## EXHIBIT "A"

A tract of land in the Southeast Quarter of the Northwest Quarter of Section 4, Township 14 North, Range 12, East of the 6th P.M., in the City of Omaha, in Douglas County, Nebraska, more particularly described as follows: Beginning at a point 619.91 feet North of and 1913.68 feet East of the Southwest corner of the Northwest Quarter of said Section 4, said point being on the North R.O.W. line of "J" Street, and assuming said R.O.W. line to bear due East and West, thence North 00°38'50" West for a distance of 321.33 feet to a point on the Southerly R.O.W. line of the U.P.P.R. Overmeyer Spur Track, thence on a curve to the left along said R.O.W. line, said curve having a long chord of 367.94 feet bearing North 55°45'01" East, and a radius of 393.06 feet for an arc distance of 382.91 feet, thence North 89°59'47" East for a distance of 51.40 feet to a point on the Westerly R.O.W. line of the U.P.P.R. lead track, thence South 00°39'01" East along said Westerly R.O.W. line for a distance of 528.43 feet to a point on the North R.O.W. line of "J" Street, thence South 90°00'00" West along said North R.O.W. line for a distance of 357.91 feet to the point of beginning.
