ELEVATED CROSSING AGREEMENT

For and in consideration of the sum of One (\$1.00) Dollar and other valuable consideration to us in hand paid by GREAT LAKES PIPE LINE COMPANY, a corporation, of Kansas City, Missouri, receipt of which is hereby acknowledged, Will A. Minford and Marion Minford, his wife; and Lela Minford, a widow do hereby grant to GREAT LAKES PIPE LINE COMPANY, its successors or assigns, the right to construct, maintain, operate, repair, rebuild and replace at any time its pipe line or pipe lines on elevated supports for a distance of approximately 200 feet above the surface of the ground, and to remove the same at any time, with the right of ingress and egress to and from the same, on, over and through certain lands situated in the County of Cass, and State of Nebraska and described as follows: The Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$); and Lot Number one (1), of Section Twenty Three (23), Township Eleven (11) North, Range Thirteen (13) East.

It is further agreed and understood that the GREAT LAKES PIPE LINE COMPANY, its successors or assigns, shall pay all damages to crops, surfaces, fences and other improvements which may be suffered by reason of the construction, maintenance and operation of said elevated lines.

It is further understood and agreed that the Great Lakes Pipe Line Company will Construct this overhead crossing in such manner that their line which now goes through said creek bed can and will be raised and suspended from the said overpass as soon as it is possible to do so, upon completion of their 2nd, line Dated this 15th day of August, 1949.
