ORDINANCE NO. 2074

AN ORDINANCE TO PROVIDE FOR THE ANNEXATION OF LAND AND TO PROVIDE AN EFFECTIVE DATE FOR THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF YORK, NEBRASKA:

Section 1. Annexation Ordinance.

Pursuant to Neb. Rev. Stat. § 16-117(Supp. 2009), a Petition has been filed by the owner of property contiguous or adjacent to the City to request that said property be included within the corporate limits of the City of York. The Petition recites that C.G. Holthus is the owner of real estate described below which is urban or suburban in character:

Irregular Tract No. 7; and that part of Irregular Tract No. 1 lying north and west of Irregular Tract No. 6 and Irregular Tract No. 7, in Section Eighteen (18), Township Ten (10) North, Range Two (2) west of the 6th P.M., a part of the City of York, in York County, Nebraska

and

Irregular Tract No. 8; and Irregular Tract No. 1 except Irregular Tract No. 6 and Irregular Tract No. 7 and except that part of Irregular Tract No. 1 lying north and west of Irregular Tract No. 6 and Irregular Tract No. 7, in Section Eighteen (18), Township Ten (10) North, Range Two (2) west of the 6th P.M., in York County, Nebraska

Except portions taken by the State of Nebraska for highway purposes as recorded in Book 93 at Page 190 and Book 143 at Page 129 of York County Deed Records; and Book 20 Page 85 of York County Misc. Records.

Section 2. After notice pursuant to law the City Council adopts this Ordinance to approve the Petition and the annexation of the real estate described above, and the Council hereby authorizes the annexation of such real estate to the corporate limits of the City of York, Nebraska, which property is contiguous or adjacent to the corporate limits of the City and which is urban or suburban in character.

Section 3. This Ordinance shall be in full force and effect from its passage, approval and publication as required by law.
