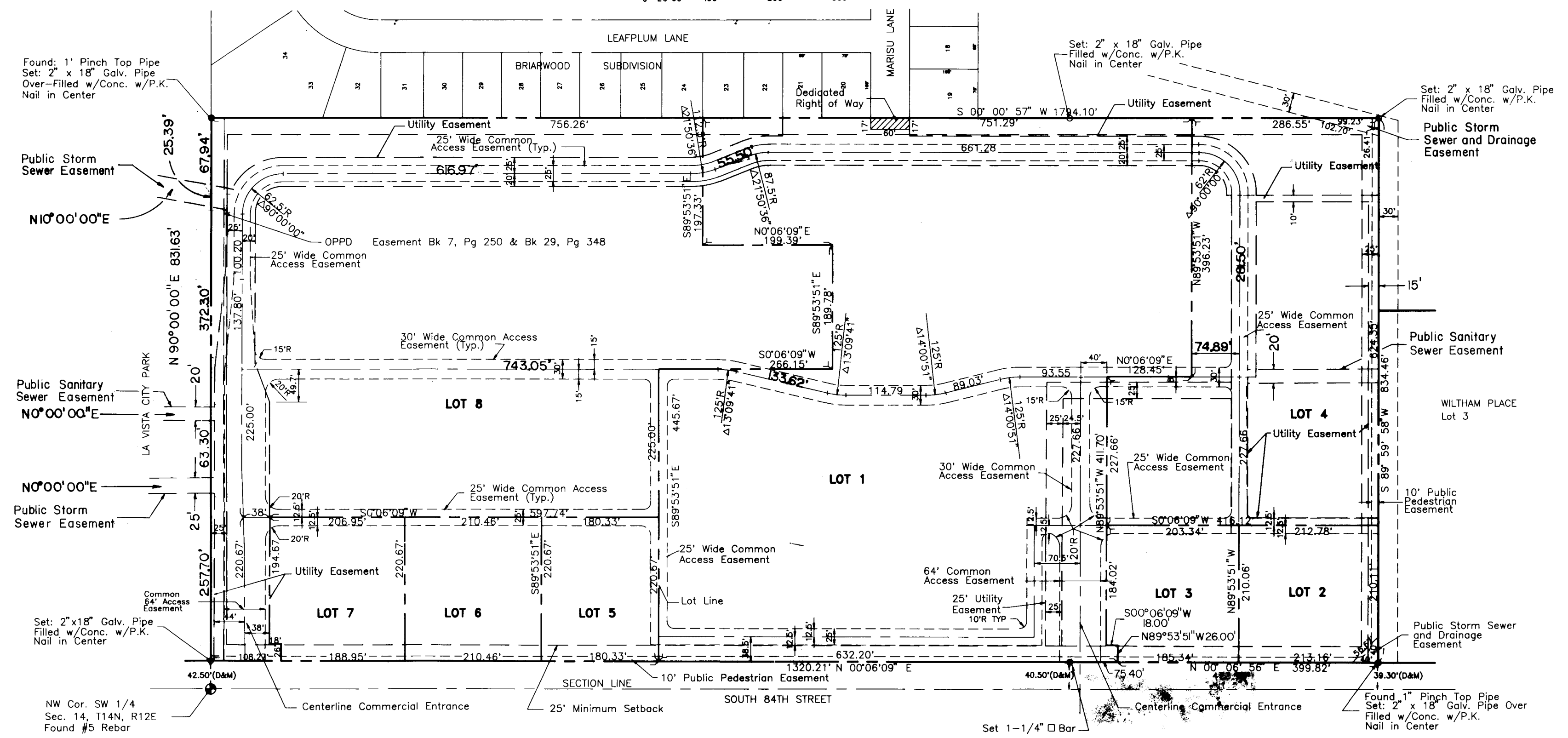
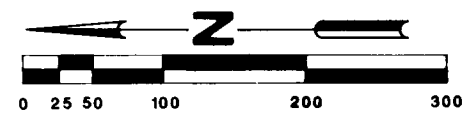

SURVEYOR'S CERTIFICATE

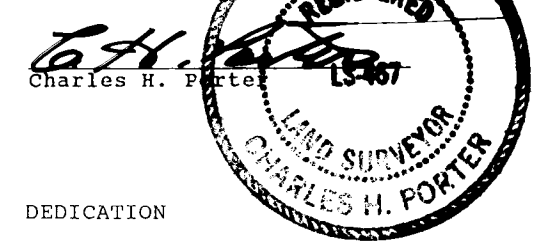
I hereby verify that I have accurately surveyed the foregoing plat, to be known as Brentwood Crossing (Lots 1 thru 8 inclusive), a subdivision of Tax Lots 2A and 2B, located in the SW 1/4 of Section 14, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, more particularly described as follows:

Referring to the Northwest corner of the Southwest Quarter of Section 14; thence easterly on an assumed bearing of N 90°00'00" E, on the north line of the Southwest Quarter of said section, a distance of 42.50 feet to the true point of beginning; thence continuing on the last described bearing, on the North line of the Southwest Quarter of Section 14, a distance of 831.63 feet; thence southerly on a bearing of S 00°00'57" W, a distance of 1794.10 feet; thence westerly on a bearing of S 89°59'58" W, a distance of 834.46 feet, to a point of intersection on the easterly Right of Way line of South 84th Street; thence northerly on the easterly Right of Way line of South 84th Street on the following described courses; N 00°06'56" E, a distance of 473.90 feet; thence N 00°05'09" E, a distance of 1320.21 feet, to the true point of beginning.

Containing a calculated area of 34.308 acres, of land, Subject to all easements, restrictions, and reservations of record.

Permanent monuments have been placed at all corners of the Subdivision boundary and a bond has been furnished to the City of La Vista to ensure placing of permanent monuments at all corners of all lots, angle points, and ends of all curves. All dimensions shown are in U.S. feet and decimals of a foot.

DEDICATION

Know all men by these presents that Wal-Mart Stores, Inc., owners of the property described in the Surveyor's Certificate and embraced within this plat have caused said land to be subdivided into lots to be numbered as shown, said subdivision to be hereinafter known as Brentwood Crossing (Lots 1 thru 8 inclusive), and we do hereby ratify and approve of the disposition of our property as shown on this plat, and we do hereby grant in perpetuity the easements all as shown on this plat to the City of La Vista, Omaha Public Power District, Metropolitan Utilities District, U.S. West Communications, Peoples Natural Gas Company, and any company which has been granted franchise to provide a cable television system in the area to be subdivided, their successors and assigns, to allow entry for the purpose of construction, reconstruction, replacement, repair, operation and maintenance of wires, cables, conduits, fixtures, poles, towers, pipes and equipment for the distribution of electricity, gas, telephone, cable television, wastewater collectors, storm drains, water mains, and all appurtenances thereto, over, upon or under any easements shown thereon.

Direct access to South 84th Street (Nebraska Highway 85) is hereby relinquished from Lots 2,3,5,6, and 7.

Direct access to Marisu Lane is hereby relinquished from Lot 1.

Direct access to South 84th Street (Nebraska Highway 85) shall be limited to two Commercial Entrances, one on Lot 1 and one on Lot 8.

Easements are reserved for the use of all accesses to public street for ingress of egress from and to such street, which are appurtenant to any platted lot.

No permanent buildings shall be placed in the said easement ways, but the same may be used for gardens, shrubs, landscaping, and other purposes that do not then or later interfere with the aforesaid use or rights herein granted.

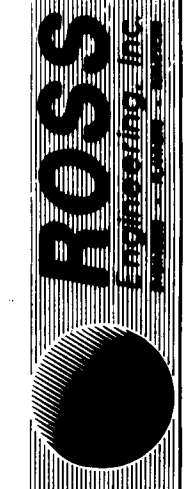
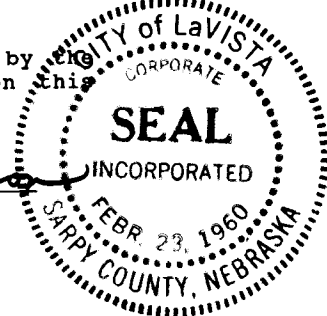
