## **QUITCLAIM DEED**

KNOW ALL MEN BY THESE PRESENTS, that Carrie A. Kiger, a single person, Grantor, in consideration of One Dollar (\$1.00) and other valuable consideration received, does hereby grant, bargain, sell, convey and confirm unto Carrie A. Kiger, Trustee of the Carrie A. Kiger Revocable Trust, dated June 10, 1998, as amended, and all successors in trust, the real property (as defined in Nebr. Rev. Stat. § 76-201) hereinafter described in Dodge County, Nebraska:

## PARCEL ONE:
