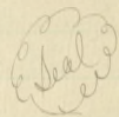

We, the undersigned, six disinterested freeholders, residents of said County, by you duly selected and summoned and sworn as Commissioners to carefully inspect and view the real estate in said County, through over and upon which the Omaha Southern Railway Company desires to locate its road and depot grounds, and assess the damages which the owners and parties therein interested shall sustain by the appropriation of the lands herein-below described to the use of said railroad Corporation, do report that on the 6th day of June 1890, the time fixed by the notices to the owners and interested parties filed, we together personally examined the several parcels and tracts of land and lots herein below described, together with the improvements thereon, and upon such view we assess the damages which the owners and parties interested will sustain by the appropriation of said lands upon the several tracts as follows.
