## CONTRACT

This identure made this 6th day of January, 1927, by and between Nebraska Gas & Electric Company, a corporation hereinafter called "The Company" and Chester E.Welshimer and Mildred Welshimer, Husband and Wife, of the County of Cass, State of Nebraska, hereinafter called "Grantors":

WITNESSETH: That for and in consideration of Seventy Five (75) Dollars, receipt whereof is hereby acknowledged by the grantors and mutual covenants and agreements herein contained the grantors do hereby grant and convey unto the Company, its lessees, successors and assigns, the perpetual right, privilege, easement, authority and right of way to construct, operate and maintain its poles, electric transmission lines, necessary wires, guts, supports, cross arms and other fixtures and appliances, over, upon, along, and above the following described property, situated in Cass County, State of Nebraska, to-wit:

Lot 30 of the NorthEast Quarter (NE+) of the NorthEast Quarter (NE+) of Section 24--Township 12 N.--Range 13 E. of the 6th P.M., the foregoing description including Lots 1 to 8 Inclusive of Burris Addition and also fractional lot 30.

The electric transmission line shall be built according to the general specifications and restrictions attached hereto and hereby made a part hereof and marked exhibit "A".
