1 AN ORDINANCE vacating S.W. 2nd Street from the north line of West L
2 Street to the north line of West J Street; West L Street from the west line of
3 S.W. 1st Street to the east line of S.W. 2nd Street; West K Street from the east
4 line of S.W. 2nd Street east 175.00 feet; the east-west alley and the north-south
5 alley located in Block 2, Boyer and Davis Subdivision; and all of the east-west
6 alley located in Block 3, and that portion of the north-south alley located in
7 Block 3 lying between the north line of the east-west alley and the north line
8 of West J Street, in Boyer and Davis Subdivision, generally located west of S.W.
9 2nd Street, north of West J Street to West L Street, and retaining title thereto
10 in the City of Lincoln, Lancaster County, Nebraska.

11 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

12 Section 1. That S.W. 2nd Street from the north line of West L Street
13 to the north line of West J Street; West L Street from the west line of S.W. 1st
14 Street to the east line of S.W. 2nd Street; West K Street from the east line of
15 S.W. 2nd Street east 175.00 feet; the east-west alley and the north-south alley
16 located in Block 2, Boyer and Davis Subdivision; and all of the east-west alley
17 located in Block 3, and that portion of the north-south alley located in Block
18 3 lying between the north line of the east-west alley and the north line of West
19 J Street, both located in Boyer and Davis Subdivision; all located in the
20 Northeast Quarter of Section 27, Township 10 North, Range 6 East, Lincoln,
21 Lancaster County, Nebraska, be and the same are hereby vacated, subject to the
22 title of said streets and alleys being vacated remaining in the City of Lincoln,
23 Nebraska.


