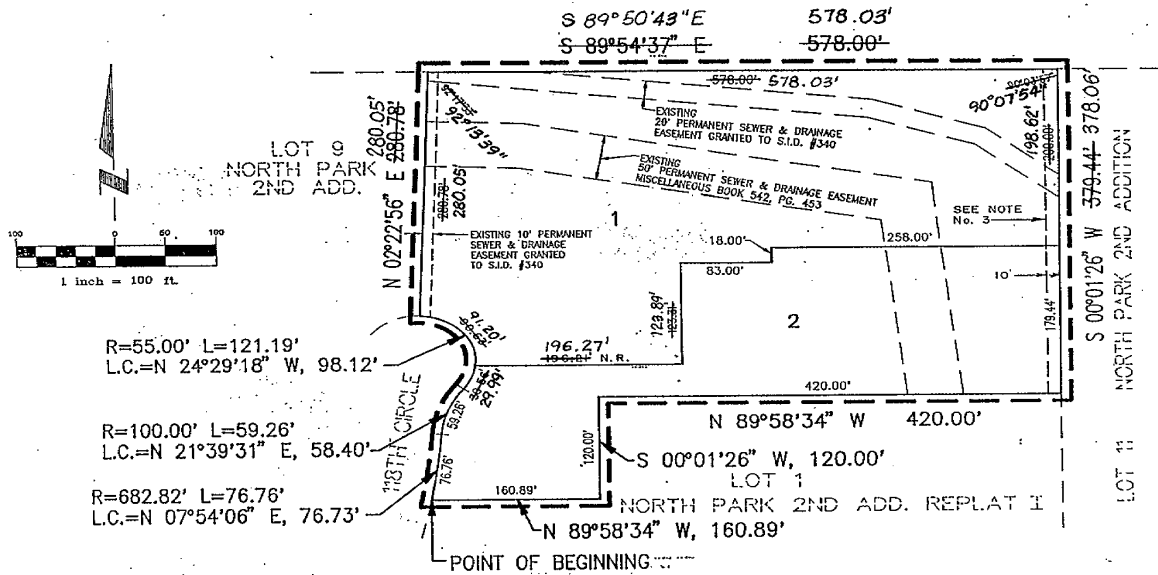

- The Northeastly angle of Lot 1 to read 90°07'51" instead of 90°03'57".
- The distance on the east line of Lot 1 to read 198.62 feet instead of 200.00 feet.
- The distance on the east line of North Park 2nd Addition Replat III to read 378.06 feet instead of 379.44 feet.
- The distance on the west line of Lot 1 to read 280.05 feet instead of 280.78 feet.

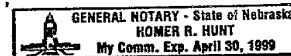
