DISCLAIMER AND RELEASE

KNOW ALL MEN BY THESE PRESENTS, that OMAHA PUBLIC POWER DISTRICT, a public corporation, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of the Plat and Dedication of North Park 2nd Addition Replat 1 and North Park 2nd Addition Replat III, Additions as surveyed, platted and recorded in Douglas County, Nebraska, over, upon, along and above the following described property:

A strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common lot lines of Lot One (1), North Park 2nd Addition Replat I and Lot Two (2), North Park 2nd Addition Replat III, now known as Lot 4, NP Business Park, and Lot 2, North park 2nd Addition Replat Six. (See exhibit "A" attached for sketch and description of the easement area.)

Said Plat and Dedication of North Park 2nd Addition Replat I was filed for record May 17, 1995, in Miscellaneous Book 1147 at Page 277 in the office of the Register of Deeds in Douglas County, Nebraska.

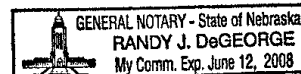

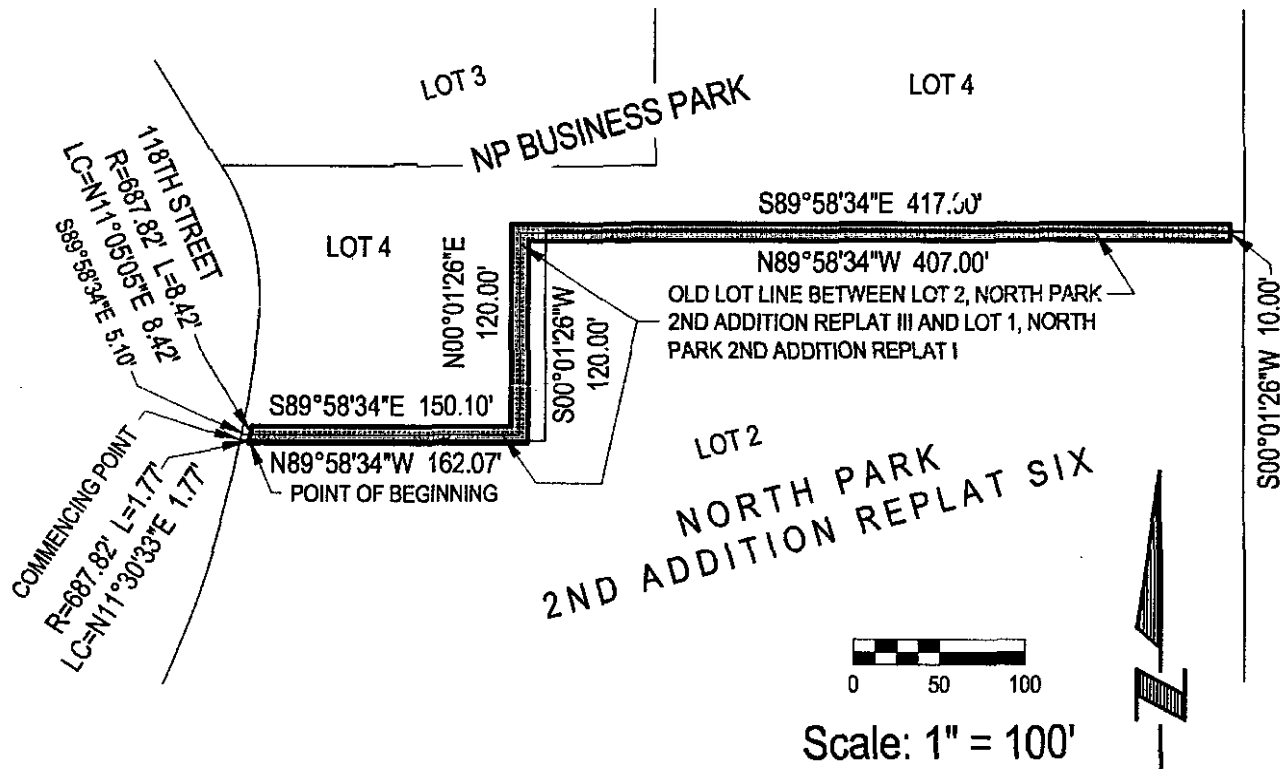
