## DECLARATION OF RESTRICTIVE COVENANTS

THIS DECLARATION OF RESTRICTIVE COVENANTS ("Declaration") is made effective this 11<sup>th</sup> day of June, 2015, by and between **Great Southern Bank**, a Missouri chartered trust company, 218 S. Glenstone, PO Box 9009, Springfield MO 65802 ("Declarant") and **Great Western Bank**, a South Dakota banking corporation, 14545 West Center Road, Omaha NE 68116 ("Great Western Bank").

WHEREAS, Great Western Bank is the fee simple owner of Lot 5, Applewood Replat 1, an Addition, as surveyed, platted and recorded in Douglas County, Nebraska ("Property"); and

WHEREAS, Great Western Bank and Declarant entered into a Real Estate Purchase Agreement on April 8, 2015 ("Purchase Agreement") wherein Great Western Bank has agreed to sell and convey to Declarant the Property; and

WHEREAS, a condition of the Purchase Contract and material consideration for the sale and conveyance pursuant thereto is that Declarant impose certain restrictions on the use of the Property, which restrictions shall preserve the values and character of the Property for the direct benefit of the Property and which restrictions are material consideration to Great Western Bank.

NOW, THEREFORE, in consideration of the sale and conveyance of the Property to Declarant, and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. **Declaration of Restrictive Covenants.** The Declarant hereby irrevocably declares that said Property shall be held and hereafter sold, transferred or conveyed, subject to the following restrictions, covenants and conditions:
  - (a) No part of the Property shall be used for the operation of any bank, savings and loan association, savings bank, credit union, finance company, mortgage banker, loan production office, or any other financial institution, association or agency which provides depository and/or loan products or services to the general public, including any ATM services.

- 2. **Duration and Binding Effect.** This Declaration and all restrictions, covenants and conditions set forth herein shall remain in full force and effect for a period of six (6) months from the effective date of this Declaration and shall run with the land and shall be binding upon the Declarant and its successors, assigns and all persons or entities having or acquiring any right, title or interest in and to the Property or any part thereof, and their respective agents, representatives, customers, invitees, guests, tenants, successors, assigns, heirs, legal representatives and estates.
- 3. Amendment or Termination. No amendment, modification or termination of this Declaration shall be permitted without the prior written consent of Great Western Bank and its successors and assigns.
- 4. **Enforcement.** In the event of any violation or threatened violation of this Declaration, Great Western Bank and its successors and assigns, shall be entitled to any and all remedies provided at law and at equity, including but not limited to injunctive relief and/or actual damages.
