ASSIGNMENT

FOR VALUE CONSIDERATION, the undersigned hereby transfer and assign to WLG Enterprises, Inc., a Nebraska corporation ("Assignee") all rights, powers, options and privileges reserved unto the undersigned under that certain Declaration of Protective Covenants, Conditions, Restrictions, Reservations and Easements for Lake Aero and Lake Aero Replat and Rules and Regulations Governing Use of Lake Aero dated June 15, 1983, and recorded June 26, 1987, in Book 819 at Page 20 of the Miscellaneous Records of Douglas County, Nebraska, as amended by that certain Amendment dated August 8, 1991, and recorded September 13, 1991, in Book 978 at Page 350 of the Miscellaneous Records of Douglas County, Nebraska, which Declaration, as amended, places certain covenants on Lots One (1) through Thirty-four (34), Lake Aero Replat, Lots Ninety-eight (98) and Ninety-nine (99), Lake Aero, and all the remaining platted and vacated portion of Lake Aero, as more particularly described in a certain Plat Vacation Exhibit for Lake Aero Replat dated January 28, 1985, and filed in Book 847 at Page 135 of the Miscellaneous Records of Douglas County, Nebraska, all located in part of Section 18, Township 15 North, Range 10 East, in Douglas County, Nebraska.

This Assignment is being executed and delivered at this time to confirm this intent.
