DECLARATION AND RESERVATION OF EASEMENT

THIS DECLARATION AND RESERVATION OF EASEMENT is made this 10th day of December, 1978, by MILLARD PLAZA ASSOCIATES, a Nebraska general partnership, hereinafter called "Millard."

W I T N E S S E T H :

WHEREAS, Millard is the owner of a certain parcel of real estate containing approximately 20 acres (the "Shopping Center Property"), and Millard is developing said Shopping Center Property generally as a commercial shopping center in accordance with a master plan which provides for common streets and driveways;

WHEREAS, the master plan for the Shopping Center Property provides for those certain common streets and driveways described and shown on Exhibit "A" attached hereto and incorporated herein by this reference (herein called "common streets");

WHEREAS, parcels of the Shopping Center Property have been transferred and conveyed by Millard to purchasers and together with such transfer and conveyance Millard has granted to such purchasers nonexclusive easement rights over and across the common streets. Attached hereto marked Exhibit "B" is a

list of said parcels setting forth the name of the owner thereof and the respective percentage share of the total cost of maintenance to be borne by each owner; and

WHEREAS, Millard has retained the ownership of certain parcels of the Shopping Center Property described on Exhibit "C" attached hereto and incorporated herein by this reference (herein called "Retained Property").

NOW, THEREFORE:

1. Millard does hereby declare that it is the owner of the common streets and that it holds title to said common streets subject to the nonexclusive easement rights heretofore granted by Millard to purchasers of various parcels of the Shopping Center Property.

2. Millard does hereby reserve unto itself and its successors and assigns a perpetual nonexclusive easement over and across said common streets.

3. Purpose of Reserved Easement. The purpose of the easement reserved herein shall be for pedestrian and vehicular access to and from the Retained Property and to and from Highway 50, 138th Street and "U" Street by way of said common streets. The common streets and driveways shall be kept open at all times and no parking of any automobiles or any other obstructions shall be permitted thereon.

4. Grading, Surfacing and Maintenance of Common Streets.

Millard has heretofore, at its cost and expense, provided for the grading and surfacing of said common streets. Millard further declares that it will perpetually maintain and repair said common streets, including the landscaping thereof, so that the same shall be kept in a neat, clean and safe condition. Maintenance shall include repair of the surface condition, painting and striping, care of any landscaping and the removal of any and all accumulations of ice, snow, dirt and debris from the common streets. Millard shall perform such maintenance in a reasonable and diligent manner and shall use every effort to perform such maintenance at the lowest possible cost. The maintenance performed by Millard shall be such as is reasonably necessary for the proper care of said common streets and driveways and to keep the same in a neat, clean and sanitary condition.

5. Cost of Common Street Maintenance. Each of the purchasers of various parcels of the Shopping Center Property have heretofore agreed to pay their proportionate share of the total actual cost of the common street maintenance described above. Millard does hereby agree to pay its proportionate share of the total cost of the common driveway maintenance described herein in respect to the Retained Property.

Millard's share of the actual cost of the common street maintenance attributable to its ownership of the Retained Property shall be as set forth on Exhibit "C." At the end of each month, Millard shall submit to the owners of all parcels of the Shopping Center Property a detailed statement showing an itemization of the total actual cost. At the end of each month, Millard shall submit to the owners of all parcels of the Shopping Center Property a detailed statement showing an itemization of the total actual cost of said payments, and each owner of parcels of the Shopping Center Property, including Millard, shall pay their respective share of said cost within 30 days after receipt of such invoice.

6. Binding Upon Successors. The terms and conditions of this Declaration and Reservation of Easement shall be binding upon, and shall inure to the benefit of, the heirs, executors, administrators, personal representatives, successors and assigns of Millard and any and all other person or entities claiming by, through or under Millard.

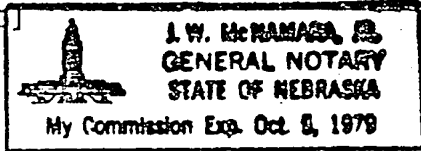

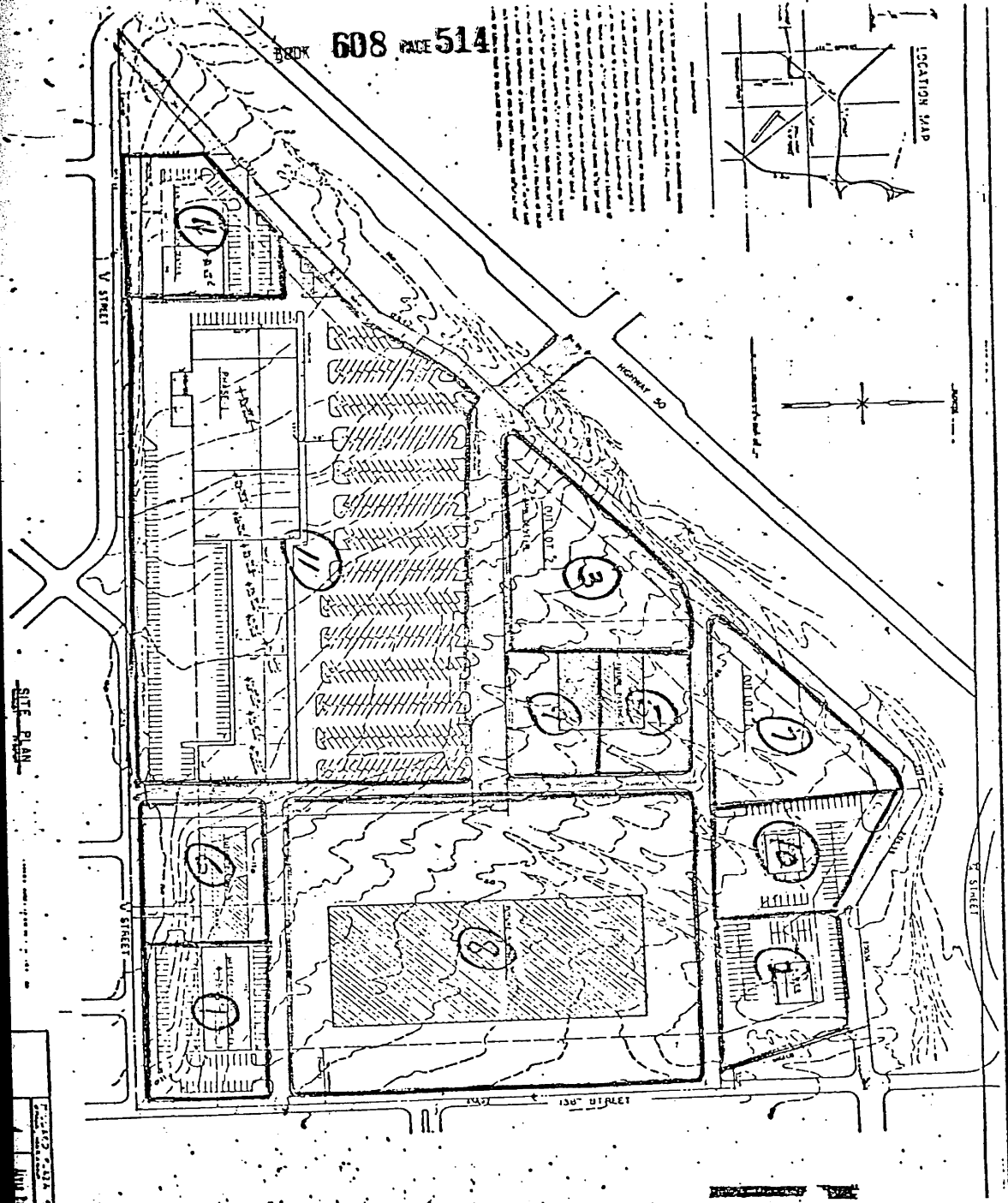
