SUBORDINATION AGREEMENT

SUBORDINATION AGREEMENT

WHEREAS, Humboldt Workshop Service Enriched Housing I, L.L.L.P. (the "Owner") did execute and deliver to the Iowa Department of Economic Development ("IDED") a mortgage, recorded on November 28, 2006 as Instrument Number 062649 in the Humboldt County Recorder's Office (the "Subordinate Mortgage"), to secure a loan in the aggregate amount of \$784,297, encumbering the property described in Exhibit A attached hereto; and

WHEREAS, the Owner has executed and delivered to the Iowa Finance Authority (the "Authority") a Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Financing Statement dated as of February 1, 2010 (as the same may be amended, modified, extended, renewed and/or restated from time to time, the "Senior Mortgage"), in the amount of \$290,000, and this Senior Mortgage has been or will be recorded in the Office of the Humboldt County Recorder; and

WHEREAS, IDED does wish to subordinate the above-described Subordinate Mortgage in its favor to the above described Senior Mortgage in favor of the Authority;

NOW THEREFORE, IDED, which is the holder of the above-described Subordinate Mortgage, for itself and its successors and assigns, does hereby subordinate such Subordinate Mortgage to the above-described Senior Mortgage in favor of the Iowa Finance Authority, the effect of this subordination being to prioritize the respective liens set forth in the documents as if the above-described Subordinate Mortgage had been filed for record after the above-described Senior Mortgage to the Iowa Finance Authority, regardless of the order of recording and indexing of the Senior Mortgage and the Subordinate Mortgage. IDED does further agree that: (i) the indebtedness evidenced by the Subordinate Mortgage is and shall be subordinated in right of payment, to the prior payment in full of the indebtedness evidenced by the Senior Mortgage, and (ii) the Subordinate Mortgage and the other documents executed in connection therewith are and shall be subject and subordinate in all respects to the liens, terms, covenants and conditions of the Senior Mortgage and the documents executed in connection therewith.
