together with the right of ingress and egress over the adjacent lands of the GRANTOR, his successors and assigns,
for the purposes of this easement.

The easement shall be _____ 30 _____ feet in width, the center line of which is described as follows:

Beginning at a point on station 769 & 25 on center line of Iowa Highway #6 & #6
NW-NE Sect. 13, T 75 N, R 40 W, 90° to center line and 129° in a Southwesterly
direction, thence 172.5 Northwesterly to a point 90° and 43.5' from centerline
Highway at station 769 & 25, thence 70° Southwesterly in a line 43.5' from centerline
and parallel to centerline Highway #6 & #6, thence 90° to a point 308' from
centerline Highway #6 & #6, thence 750° Northwesterly in a line 308' from
and parallel to centerline Highway #6 & #6.

The consideration hereinabove recited shall constitute payment in full for any damages to the land of the GRANTOR,
his successors and assigns, by reason of the installation, operation, and maintenance of the structures or improvements
referred to herein. The GRANTEE covenants to maintain the easement in good repair so that no unreasonable damage
will result from its use to the adjacent land of the GRANTOR, his successors and assigns.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit
of the GRANTEE, its successors and assigns.
