EASEMENT

THIS AGREEMENT, entered into at Avoca, Iowa on this
8th day of June, 1994, by and between Roger A.
Nelson, a single person, of Panora, Iowa, First Party, and the
City of Avoca, Iowa, Second Party;

WITNESSETH: That for good and valuable consideration,
receipt of which is hereby acknowledged, and payment of all costs
by City of Avoca, Iowa, and the grantors shall have the right to
hook into the sewer for the normal hookup fee. The First Party
has this day conveyed unto the City of Avoca, Iowa, a permanent
easement for the purposes of the construction of a sewer line
together with drainage improvements, including the perpetual
right to enter upon the real estate as hereinafter described at
any time it sees fit for the purpose of repair and maintenance of
said sewer line. That the City is allowed a temporary easement
over an area fifty (50) feet wide over the property (10 feet on
the west side of center of easement and 40 feet on east side of
sewer line as constructed) hereinafter described for the purposes
of construction; a permanent easement for the sewer line and for
purposes of maintenance over an area twenty (20) feet wide (ten
(10) feet on either side of the eight (8) inch sewer line as
constructed), and the right of ingress and egress to the said
sewer line for purposes of maintenance and construction.

The full legal description of the land affected by the
granting of this easement and right of way is located in
Pottawattamie County, Iowa, and is more particularly described as
follows:

Part of Lot 5 of the Avoca Land and Loan Company's Addition to
the City of Avoca, Pottawattamie County, Iowa. More particularly
described as follows: Commencing at the southeast corner of the
NW1/4 NW1/4 NE1/4 of Section 9, Township 77 North, Range 39 West
of the 5th P.M. in Pottawattamie County, Iowa; thence S. 0
degrees 58.8' E. along the centerline of Willow Street 127.71
feet to the point of beginning; thence S. 88 degrees 37.5' W.
487.64 feet to a point on the east right of way line of Highway

No. 59; thence along said right of way line S. 1 degree 18.3' W. 126.54 feet; thence along said right of way line S. 3 degrees 17' W. 408.37 feet to a point on the north line of Wood Street; thence S. 89 degrees 0' E. along the north line of Wood Street 515.25 feet to a point on the centerline of Willow Street; thence N. 0 degrees 05.8' W. along the centerline of Willow Street 554.95 feet to the point of beginning.

The above described tract of land contains 6.25 acres more or less including Willow Street right of way.

The east line of the NW1/4 NW1/4 NE1/4 of said Section 9 is assumed to bear N. 0 degrees 0' E. for this description.

The permanent easement hereby granted covers a strip of ground twenty (20) feet in width, which shall be located ten (10) feet on either side of the center of the sewer line after construction, the centerline which will be approximately 297.50 feet west of the west right of way line of Willow Street.

IT IS FURTHER AGREED that no buildings shall be place on the twenty (20) foot permanent easement.

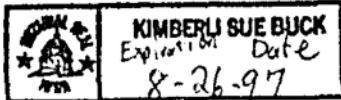
