EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That TAYLOR FAMILY PARTNERSHIP, herein called "Grantor", whether one or more, record owner of the real property hereinafter described, for and in consideration of the sum of SIX HUNDRED SEVEN AND NO/100 DOLLARS, (\$607.00), duly paid, the receipt whereof is hereby acknowledged, and the further consideration of the performance of the covenants and agreements by Grantee as hereinafter set out and expressed, does hereby GRANT, REMISE and RELINQUISH unto the CITY OF LINCOLN, NEBRASKA, a municipal corporation, its successors and assigns, herein called "Grantee", the RIGHT, PRIVILEGE and EASEMENT to construct, reconstruct, maintain, operate, and replace access, and appurtenances thereto belonging, over and through the following described real property, to-wit:

Portions of Lots 1, 2, and 3, Block 4, Eastmont Addition in Section 28, T10N, R7E, of the 6th Principal Meridian, Lincoln, Lancaster County, Nebraska, more particularly described as follows:

Commencing at the northwest corner of Section 28; thence easterly along the north line of said Section 28, a distance of 473.41 feet; thence south along a line which deflects 90° right from the last described course, a distance of 50.82 feet to the Point of Beginning; thence east along a line which deflects 89°08'30" left from the last described course, a distance of 6.48 feet; thence southwesterly along a line which deflects 101°21'48" right from the last described course, a distance of 30.60 feet to a point on the west line of Lot 1; thence north along said west line a distance of 30.00 feet to the Point of Beginning. Said access easement contains a calculated area of 97.16 square feet, more or less.
