

This matter came on for hearing before the Court on the 20th day of September, 2017 on the Motion for Partial Summary Judgment filed by the Plaintiff and the Motion for Summary Judgment filed by the Defendant. The Plaintiff appeared through counsel, Michael J. Mullin, and the Defendant appeared through counsel, Damien Wright. Evidence was adduced and the matter submitted to the Court, at which time the Court took the matter under advisement.

The Court has reviewed all of the evidence herein, specifically Exhibits 1 through 12. The Court has further reviewed Exhibit 11 multiple times for the reason that Exhibit 11 is a video tape of the actual incident itself. Having reviewed all of the evidence herein, the Court is satisfied that there is no question of material fact relating to the operation of the automatic sliding doors in the Hy-Vee Store on the date of this incident. The video evidence shows the doors to be working properly. The video evidence further shows the Plaintiff entering the doorway at the extreme right hand side while the doors were just beginning to close and as the doors touched the Defendant, they immediately re-opened. This Court is of the view that there is no material question of fact relating to the operation of the doors and further, that res ipsa loquitur does not apply. The uncontroverted visual evidence shows Plaintiff stepping into the closing door which thereafter automatically reopened immediately as it was designed to do.

Based on above, the Plaintiff's Motion for Partial Summary Judgment must be denied and the Defendant's Motion for Summary Judgment must be granted.





IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Plaintiff's Motion for Partial Summary Judgment be and the same is hereby denied.

IT IS FURTHER ORDERED that Defendant's Motion for Summary Judgment is granted and judgment is granted in favor of the Defendant against the Plaintiff.
