That part of the NE 1/4 of the SW 1/4 of Section 30, T 15 N, R 13 E of the 6th P.M., and part of Lot 8, Block 5, Brookline Addition, Douglas County, Nebraska, described as follows: Beginning at a point where the North line of Lot 8, Block 5, Brookline Addition to the City of Omaha, in Douglas County, Nebraska, Intersects the Southerly line of Center Street; thence in a Southeasterly direction perpendicular to the Southerly line of Center Street 107 feet more or less (107.91 feet actual) to the boundary line of the Bohemian Cemetery; thence S46 degrees 35 minutes W for 126.0 feet (S47 degrees 04 minutes 40 seconds for 126.00 feet actual); thence S26 degrees 45 minutes W for 61.6 feet (S23 degrees 26 minutes 50 seconds W for 60.45 feet actual; thence N42 degrees 58 minutes W for 132 feet more or less (132.00 feet actual) to the Southerly line of Center Street; thence Northeasterly along the Southerly line of Center Street for 183.35 feet more or less (181.40 feet actual) to the point of beginning.
