MEMORANDUM OF OPTION AND LEASE AGREEMENT

**ORIGINAL**

This Memorandum dated this 2nd day of July, 1996, by and between **Darrell J. Logemann and Coe Leta F. Logemann**, RR 1, Box 1, Bennington, Nebraska 68007 (hereinafter "Lessor") and **Omaha Cellular Telephone Company**, c/o U S WEST NewVector Group, Inc., 3350 161st Avenue S.E., P.O. Box 91211, Bellevue, Washington 98009-9211 (hereinafter "Lessee"), is a record of that Option and Lease Agreement (hereinafter "Agreement") between Lessor and Lessee dated July 2nd, 1996, which Agreement includes in part the following terms:

1. Leased Premises. The Agreement pertains to real property which is described in Exhibit "A" (hereinafter "Property"), which is attached hereto and incorporated herein by this reference.

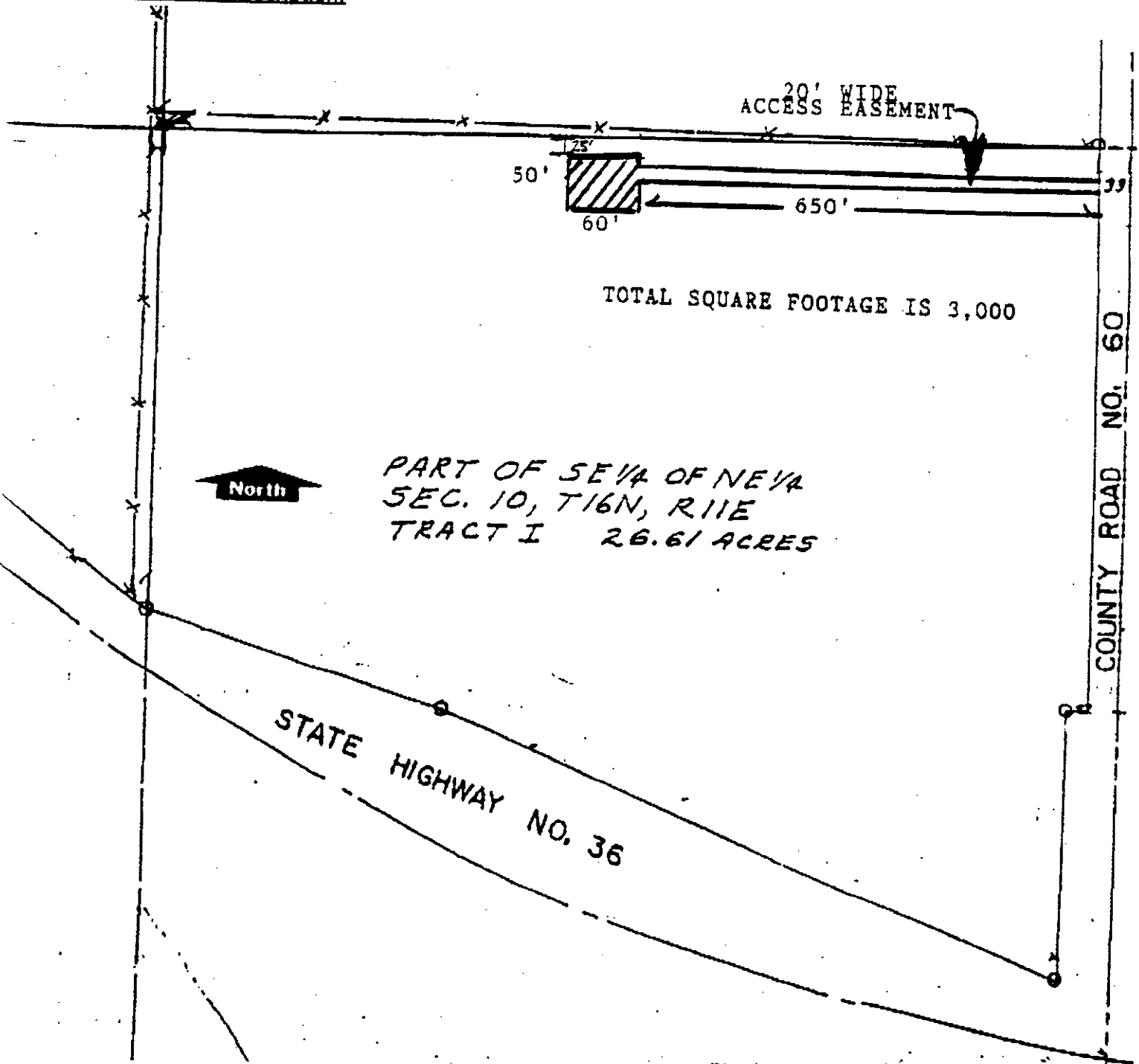
