# **QUITCLAIM DEED**

GRANTOR, CHICAGO CENTRAL & PACIFIC RAILROAD COMPANY, a Delaware corporation, of 455 North Cityfront Plaza Drive, Chicago, Illinois 60611, for and in consideration of the sum of TEN AND 00/100 DOLLARS (\$10.00) in hand paid and other good and valuable consideration, and pursuant to authority given by the Board of Directors of such corporation, Conveys and Quitclaims to the CITY OF OMAHA, NEBRASKA (the "GRANTEE"), of 1819 Farnam Street, Omaha, Nebraska, 68183, the following described lands and property situated in the County of Douglas and State of Nebraska to wit:
