
THIS INDENTURE WITNESSETH, That the Grantor, OMAHA BRIDGE AND TERMINAL RAILWAY COMPANY, a corporation of the State of Nebraska, for and in consideration of the sum of Ten Thousand Dollars (\$10000) in hand paid, hereby conveys in fee simple to LE ROY I. REYNOLDS, CHARLES A. and NEEDHAM/PHILIP H. AMIS, a co-partnership of Douglas County, Nebraska, and doing business as Missouri Valley Machinery Co., the following described lands and property situated in the County of Douglas and State of Nebraska, to-wit:







Beginning at the southwest corner of said Lot Seven (7); thence east along the south line of said Lot sixty-three and nine tenths (63.9) feet; thence northerly on a straight line one hundred thirty-two and twenty-five hundredths (132.25) feet to a point on the north line of said Lot Seven (7), which is sixty-two and ninety-four hundredths (62.94) feet east of the northwest corner of said Lot; thence west along the north line of said Lot Seven (7) a distance of sixty-two and ninety-four hundredths (62.94) feet to the northwest corner thereof; thence south along the west line of said Lot Seven (7) a distance of one hundred thirty-two and twenty-five hundredths (132.25) feet, more or less, to the point of beginning, containing an area of twenty-five thousand eight hundred forty-four (25844) square feet, more or less.

All of Lots Three (3) and Four (4) in Block Thirty-eight (38), Original City of Omaha, and that part of Lot Two (2) in said Block Thirty-eight (38), bounded and described as follows:

Beginning at the southwest corner of Lot Two (2) in said Block Thirty-eight (38); thence east along the south line of said Lot Two (2), sixty-two and eight tenths (62.8) feet; thence northwesterly on a straight line sixty-six and four tenths (66.4) feet to a point fifty-five and eighty-five hundredths (55.85) feet east of the west line of said Lot Two (2), measured at a right angle thereto; thence continuing northwesterly sixty-eight and twenty-five hundredths (68.25) feet to a point in the north line of Lot Two (2), thirty-eight and fifty-five hundredths (38.55) feet east of the northwest corner of Lot Two (2); thence west along said north line of Lot Two (2), thirty-eight and fifty-five hundredths (38.55) feet to the northwest corner of said Lot; thence south along the west line of Lot Two (2) to the point of beginning, containing an area of twenty-four thousand five hundred one (24501) square feet, more or less.

That part of Lots Five (5) and Six (6) in Block Twenty-eight (28), Original City of Omaha, bounded and described as follows:

Beginning at the southwest corner of said Lot Five (5); thence east along the south line of said Lots Five (5) and Six (6) in Block Twenty-eight (28), a distance of ninety-three and nine tenths (93.9) feet; thence northwesterly along a straight line to a point in the north line of said Lot Five

(5) which is thirty-eight and forty-five hundredths (38.45) feet east of the northwest corner of said Lot; thence west along the north line of said Lot Five (5) a distance of thirty-eight and forty-five hundredths (38.45) feet to the northwest corner of said Lot; thence south along the west line of said Lot Five (5) a distance of one hundred thirty-two and nine tenths (132.9) feet, more or less, to the point of beginning, containing an area of eight thousand seven hundred ninety-five (8795) square feet, more or less.

All as shown outlined in red on blue print attached hereto and made a part hereof.

The Grantees in accepting this deed agree to assume and pay the 1945 State and County taxes and the 1946 City taxes and all subsequent taxes levied upon the within described lands.

There is excepted from this conveyance and reserved to the Grantor, its successors and assigns, the railroad tracks and appurtenances now located upon a portion of the within described lands, with the right to operate the same as presently located, or as hereafter relocated, and with the further right to remove same at any time.

Grantor hereby warrants the title against all persons whom-soever.


