The Dissolution of Marriage Petition came on for final hearing on October 25, 2017. The Plaintiff, Ms. Uhrich, was personally present with her counsel Mr. Icenogle. The Defendant, Mr. Uhrich, was present representing himself. The case was taken under advisement to consider the evidence submitted. Now on this 26th day of December 2017 the Court, having considered the testimony of the witnesses, their conduct and demeanor while testifying and the other evidence presented and the relevant law **FINDS** as follows.

I. The Court has subject matter jurisdiction over this action and personal jurisdiction over the parties. The Court finds that based upon the evidence the marriage of the parties entered into on July 20, 2017, in Grand Island, Hall County, Nebraska is irretrievably broken and the same should be and hereby is dissolved.

II. Ms. Uhrich's former name of Monie is restored to her.

III. **CUSTODY AND PARENTING TIME**

A. CUSTODY

The Court finds it is in the best interests of the minor children that their legal and physical custody be placed with Ms. Uhrich for the reasons set forth below.

Mr. and Ms. Uhrich met when Ms. Uhrich was Mr. Uhrich's drug dealer. Ms. Uhrich was convicted of distribution of controlled substance in 2003 and has successfully completed probation. No evidence was presented showing that Ms. Uhrich currently is abusing controlled substances. The parties are the parents of Christopher born in 2004 and Alexis born in 2007. They married in 2013.

Ms. Uhrich left the family home and children in February 2016 and after a period of housing instability moved into a home in Doniphan, Nebraska with Ms. O'Gorman with whom she is romantically involved.

Mr. Uhrich remained in the family home and received temporary custody of the children in September of 2016. Ms. Uhrich's mother now resides with Mr. Uhrich and assists with the children.

It is clear that both parents love their children. It is equally clear, however, that both parties have engaged in behaviors that are detrimental to the children's best interests.

Considering custody questions the Court considers the factors set forth in NEB. REV. STAT. §42-364 (Reissue 2016):

"...moral fitness of the child's parents, including the parents' sexual conduct; respective environments offered by each parent; the emotional relationship between child and parents; the age, sex, and health of the child and the parents; the effect on the child as the result of continuing or disrupting an existing relationship; the attitude and stability of each parent's character, parental capacity to provide physical care and satisfy educational needs of the child; and many other factors relevant to the general health, welfare, and well-being of the child." Maska v. Maska, 274 Neb. 629, 742 N.W.2d 492 (2007) (citations omitted).

Additionally, the Court is required by law to adopt a parenting plan that provides "for a child's safety, emotional growth, health, stability and physical care and regular and continuance

school attendance and progress for school-age children.” NEB. REV. STAT. §43-2923 (Reissue 2016).

From the evidence presented the Court finds that Ms. Uhrich now is in the best position to provide stability and ensure the health and safety of the minor children. The evidence indicates that Mr. Uhrich’s home is not sanitary and the Court is also concerned that Mr. Uhrich is abusing marijuana and has not demonstrated a stable pattern of employment. While it appears that Mr. Uhrich is generally a fit and loving parent it appears that his home is not the most suitable placement for the children.

B. PARENTING PLAN

The parties reached a mediated parenting time plan which is adopted. While Ms. Uhrich now wishes to modify the plan she agreed to, the Court finds that there is not sufficient evidence to show a modification is in the children’s best interests. Therefore, the Court adopts as the Parenting Plan Exhibit 37 except for summer and holiday visitation which is to be provided as set forth in Exhibit 38.

This Decree concerning parenting time and custody is to be effective December 26, 2017 after the end of the minor children’s current school term.

C. CHILD SUPPORT

Mr. Uhrich is ordered to pay child support of \$472 per month for two children to reduce to \$384 for one child as set forth on Exhibit 18, beginning January 1, 2018.

Upon the occurrence of any of the following events, child support shall terminate effective the first day of the month following the event: the child turns 19 years of age; the child

marries; the Court finds the child is emancipated; the death of the child; or further order of the Court.

All child support payments shall be paid to the Child Support Payment Center, P.O. Box 82600, Lincoln, NE 68501-2600.

Plaintiff and Defendant shall furnish to the Clerk of the District Court their addresses, telephone numbers, Social Security numbers, names of their employers, whether or not they have access to employer-related health insurance coverage and, if so, the health insurance policy information, until any judgment to pay child support is paid in full. The parties are also required to advise the Clerk of any changes in such information between the time of entry of the Decree and the payment of the judgment in full. Failure to comply with this section shall be punishable by contempt.

In the event a party fails to pay any child, medical, or spousal support payment, as such failure is certified each month by the State Disbursement Unit in cases in which court-ordered support is delinquent in an amount equal to the support due and payable for a one-month period of time, that party shall be subject to income withholding and may be required to appear in Court on a date to be determined by the Court and show cause why such payment was not made. In the event that such party fails to pay and appear as ordered, a warrant shall be issued for the arrest of that party.

Delinquent child support shall accrue interest at 3.214% per annum.

The parties shall alternate claiming the children for tax purposes with Mr. Uhrich receiving the 2017 exemptions and receiving the exemptions on odd-numbered years thereafter if he is current with his child support obligations and Ms. Uhrich receiving the exemptions in even-numbered years.

Ms. Uhrich is ordered to continue to provide health insurance for the minor children as long as it is available at a reasonable cost through her employment.

Mr. Uhrich is to pay 32 percent of medical expenses after the first \$480 noncovered medical expenses annually for each child and 32 percent of daycare expenses necessitated by Ms. Uhrich's employment.

IV. PROPERTY

Based upon the minimal evidence presented at the final hearing the Court enters the following orders concerning division property and debt.

Ms. Uhrich is awarded the personal property in her possession and the patio furniture, 60" TV, wall hangings. Ms. Uhrich is awarded as her personal nonmarital property the antique bed set, hope chest, crochet bag with needles, and other premarital property including wall hangings. Ms. Uhrich is awarded the Chrysler 200 subject to the debt thereon to Cornerstone Bank and is ordered to hold Mr. Uhrich harmless. Ms. Uhrich is awarded her Wells Fargo retirement account (Exhibit 39) and the bank accounts at Cornerstone Bank and Great Western Bank. Mr. Uhrich is ordered to pay credit card debt to Barclay, Account No. 2933 and First Premier Account #44868.

Mr. Uhrich is awarded all other personal marital property listed on the Property Statement. Mr. Uhrich is awarded as premarital property the Monte Carlo and his construction tools. Mr. Uhrich is awarded the lawnmower listed on the Property Statement subject to the debt thereon and is ordered to hold Ms. Uhrich harmless on the debt. Mr. Uhrich is awarded the motorcycle, camper, 1984 Ford van, Honda Civic and Charger subject to any debts thereon and is hold Ms. Uhrich harmless thereon. Mr. Uhrich is awarded his bank account at Great Western Bank.

Mr. Uhrich is awarded the real estate located at 207 North Third Street, Doniphan, Nebraska, which the Court finds has a value of \$95,000 subject to the debt in the amount of \$81,972.74 and is ordered to hold Ms. Uhrich harmless thereon.

Given the minimal evidence presented regarding property and debt, the Court is concerned that there may be outstanding marital debts not revealed by the evidence. The parties are ordered to each pay one-half of all marital debts.

The parties are ordered to sign and transfer all titles within 30 days of the date of the Decree.

In order to equalize the value of the division of marital property Mr. Uhrich is ordered to pay Ms. Uhrich the sum of \$2,374 within 30 days of the date of this Decree.
