ORDINANCE NO. 94-1

AN ORDINANCE ADOPTED BY THE VILLAGE OF CEDAR CREEK, CASS COUNTY, NEBRASKA PURSUANT TO VILLAGE CODE SECTION 8-301 ADOPTED TO PROVIDE A NAME FOR A STREET LOCATED WITHIN THE CORPORATE LIMITS OF SAID VILLAGE OR WITHIN THE ZONING JURISDICTION.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CEDAR CREEK, CASS COUNTY, NEBRASKA:

Section 1. The following described street is hereby named as PARSON DRIVE and is described and located as follows, to wit:

DESCRIPTION.....The centerline of a 50.00' wide right of way, 25' either side of a line described as follows: Referring to the SW Corner of the NW1/4 of the SW1/4 of Section 5-T12N-R12E of the 6th P.M., Cass County, Nebraska; thence N 0° 22' 47" W, along the West line of the NW1/4 SW1/4, 521.91' to the true point of beginning; thence N 36° 34' 01" E, 219.10'; thence N 25° 09' 51" E, 164.62'; thence N 83° 37' 54" E, 187.64' to a point on the Westerly right of way line of Platteview Drive and the termination of said roadway....said right of way is over and across Sub 5 of Lot 16, Sub 6 of Lot 16 and part of the NW1/4 of the SW1/4 of Section 5-T12N-R12E of the 6th P.M., Cass County, Nebraska.

Section 2. This Ordinance shall be in full force and effect upon passage and publication according to law.
