ON THIS 16th day of Feb., 2010, this matter came before the Court on the Plaintiff's Motion for Summary Judgment. Plaintiff appeared by and through counsel, Defendant appeared/failed to appear, pro se/through counsel.

The Court being fully advised in the premises finds as follows:

1. That there was due and proper service of summons on the Defendant as prescribed by the Nebraska Revised Statutes.
2. That the Defendant was duly served with Request for Admissions pursuant to Nebraska Discovery Rules, but that said Defendant has failed, neglected and refused to answer said Request for Admissions as required by Nebraska Discovery Rules and that said Request for Admissions shall be and hereby are deemed admitted.
3. That said Request for Admissions having been deemed admitted constitute a prima facie case against the Defendant and are a sufficient ground for liability under law and no issues as to any material fact remain and the Plaintiff is entitled to judgment as a matter of law.
4. That the Court finds there is due from the Defendant to the Plaintiff the sum of \$9,858.37, plus interest in the sum of \$2,889.53, plus costs in the amount of \$87.33 for a total of \$12,615.23. The Court finds generally in accordance with the prayer of the Plaintiff's Complaint.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that there are no genuine issues of material fact left to be tried and Plaintiff is granted judgment its favor and against the Defendant(s) in the amount of \$9,858.37 together with pre-judgment interest in the amount of \$2,889.53, plus costs in the amount of \$87.33 for a total of \$12,615.23 and post judgment interest at the rate of 2.183% per annum as allowed by law.

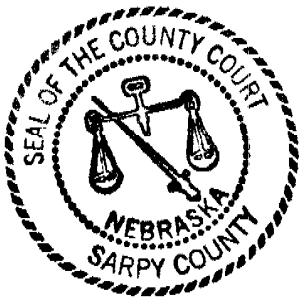
