**PARTIAL RELEASE OF SECOND AMENDMENT TO DECLARATION OF COVENANTS,

This Partial Release of Second Amendment to Declaration of Covenants, Conditions, Restrictions and Easements of Harrison Woods, a Subdivision in Sarpy County, Nebraska is made this 26<sup>th</sup> day of April, 2005, by HARRISON WOODS, L.L.C., a Nebraska limited liability company, hereinafter referred to as the "Declarant".

WHEREAS, the Second Amendment to Declaration of Covenants, Conditions, Restrictions and Easements of Harrison Woods, a Subdivision in Sarpy County, Nebraska (the "Second Amendment") was recorded with the Register of Deeds of Sarpy County, Nebraska on December 21, 2004 at Instrument No. 2004-47934.

NOW, THEREFORE, in consideration of the above, the Declarant hereby releases, discharges, rescinds, and cancels the Second Amendment solely with respect to LOTS 1, 2, ~~3~~ 4A, 5, 6, 7, 8, 9 and 10, INCLUSIVE, HARRISON WOODS REPLAT THREE and LOTS 1 and 2, HARRISON WOODS REPLAT FOUR, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska.
