AN ORDINANCE AMENDING
SECTION 2 OF ORDINANCE
NO. 221 OF THE CITY OF WILBER. SALINE COUNTY. NEBEASUCA. WITH REDARD TO
THE PLACEMENT AND MAINTENANCE OF ELECTRICAL
AND TELEPHONE LINE AND
POLES; TO REPEAL ANY
AND ALL ORDINANCES OR POLES: TO REPEAL ANY AND ALL ORBINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH: TO REPEAL SECTION 2 OF SAID ORDINANCE NO. 221 AND TO PROVIDE FOR THE TIME WHEN THIS ORDINANCE SHALL BE IN FORCE AND EFFECT.

Be it Ordained by the Mayor and City Council of the City of Wilber, Saline County, Nebraskat Section 1. That Section 2 of Ordainance No. 221 of the City of Wilber shall be amended to read as follows: "Section 2.

"The Alley more particularly described herein as comdescribed herein as commencing at the southeast corner of said Lot 261, thence running west along the south boundary line of said Lots 261, 262 and 263 to the southwest corner of Lot 263, thence south a distance of twelve (12) feet to the northwest corner of Lot 264, thence east along the north boundary of Lots 264. Lot 264, thence east along the north boundary of Lots 264, 265 and 266 to the northeast corner of Lot 266, thence north a distance of twelve (12) feet to the place of beginning, is hereby vacated and shall no longer be a public alley of the City of Wilber, Nebraska, and the area and territory included in said alley shall revert to the abutting properties according to law, the City of Wilber, to law, the City of Wilber,

abutting properties according to law, the City of Wilber, however, reserving to itself and its franchise holders the right to place, keep in place and maintain over and above said alley hereby vacated such electric and telephone lines as may be in the public interest provided however that the minimum height of said lines shall be no less than 18 feet above the ground level of said alley."

Section 2. All other Ordinance

Section 2. All other Ordinances of the City of Wilber or parts thereof conflicting herewith are hereby repealed; and Section 2 of original Ordinance No. 221 is hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after its passage, and publication as rerequired by


