

SECOND: In the event that my husband does not survive me by thirty days, then I direct that all of my property and estate pass as follows:



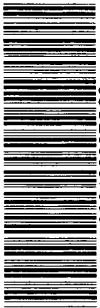




c. I give and devise to my son, Richard A. Slama, Social Security Number 508-54-0731, the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section One (1), Township Seven (7), North of Range Two (2), East of the 6th P. M., Saline County, Nebraska, and Lot Number Two (2), in Luick Addition to the Village of Dorchester, Saline County, Nebraska, to be his absolutely. In the event my son, Richard A. Slama, should predecease me, the devise made herein to him shall descend to his children, Mark A. Slama, Social Security Number 506-82-8435, and David A. Slama, Social Security Number 506-82-8424, share and share alike, to be theirs absolutely. In the event either of said grandchildren, Mark A. Slama or David A. Slama, shall predecease me, said deceased grandchild's share shall vest in the surviving grandchild.



If, for any reason, no such memorandum is in existence at my death, or if such memorandum fails to dispose of all such property effectively, I give, devise and bequeath such property to my children, to have and to hold the same for their own use, benefit and behoof, forever, share and share alike. If either of my children predeceases me, then such child's share shall pass to my deceased child's issue, per stirpes, by right of representation.

e. I give, devise and bequeath the rest, residue and remainder of my estate, real and personal, to my children,

THIRD: I nominate and appoint Joe A. Slama as Personal Representative of this my Last Will and Testament, and ask that he serve without bond. In the event of his incapacity to act for any reason, I nominate and appoint my sons, Richard A. Slama and Gene D. Slama, to act as Personal Representatives of this Will, and direct that they, likewise, not be required to give bond in such capacity..

FOURTH: Having conferred in detail regarding the provisions of this, my Last Will and Testament, with Steven J. Reisdorff, attorney of Crete, Nebraska, I hereby waive all provisions of the laws of the State of Nebraska pertaining to privileged communication between attorney and client, and expressly as to privileged communications between Steven J. Reisdorff to testify as to communications had with him regarding the provisions of my Last Will and Testament, whenever and wherever necessary to properly administer my estate.




