E A S E M E N T

In consideration of \$1.00 and other valuable consideration, the undersigned, each being the owner of the respective properties set opposite their signatures herein, hereby grant unto the Nebraska Natural Gas Co., its successors or assigns, a permanent easement along the north 10 feet of the South 43 feet of the Southwest Quarter and that part of the West Half of the Southeast Quarter lying west of C. B. & O. Railroad right of way in Section 10, Township 17, Range 8, Dodge County, Nebraska, for the purpose of constructing and maintaining a main for transmission of natural gas.

Said grantee herein shall bury the main to a depth which will not interfere with unlimited access by the owners to the highway on the south. Said grantee shall restore all dirt removed in the location or servicing of the main and any surfacing where the main crosses under driveways. The lessee shall reimburse the owners or tenants of said premises for all damage sustained by any of them arising directly out of and during any construction or maintenance of said gas main.
