

**ORDINANCE NO. 404**

An Ordinance to annex, pursuant to and in accordance with the request of the owners and inhabitants thereof, certain territory known as "Parker's First Addition to the City of Crete, Nebraska", to said City, making findings of facts pertaining thereto, providing when this ordinance shall be in effect, and repealing all ordinances and parts of ordinances in conflict herewith

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CRETE, SALINE COUNTY, NEBRASKA:

SECTION 1. That said Mayor and Council hereby find and determine the following described real estate, to-wit:

Part of the west one-half (W<sup>1</sup>/<sub>2</sub>) of Section 35, Township 8 North, Range 4 East of the 6th Principal Meridian in Saline County, Nebraska, described as follows:

Beginning at a point sixty-four (64) feet north and six hundred thirty seven (637) feet east of the northeast corner of Lot One (1), Block Two Hundred Forty three (243) in the Original Town of Crete, Nebraska; thence north one hundred fifty (150) feet; thence east seven hundred thirty three and fifty two hundredths (733.52) feet; thence north four hundred eighty three and eighty six hundredths (483.86) feet; thence east three hundred forty three and fifty two hundredths (343.52) feet; thence south six hundred ninety three and eighty six hundredths (693.86) feet; thence west one thousand fifty five and four hundredths (1055.04) feet; thence north sixty (60) feet; thence west twenty two (22) feet to the point of beginning.

lies contiguous to the corporate limits of said City of Crete, Nebraska, and has been by the act, authority and acquiescence of all of the owners and inhabitants thereof, subdivided into blocks and lots, and roads and streets, containing not more than five acres each, and the whole thereof platted, duly made out, acknowledged, and certified, as required by law, into an addition named and designated as "Parker's First Addition to the City of Crete, Nebraska", copy of which Plat, duly certified, was on May 18, 1901, filed in the office of the City Clerk of said City; that said territory should be annexed to the City of Crete, Nebraska, pursuant to and in accordance with the request of all of the owners and inhabitants of said territory, filed with said copy of said Plat, that said territory be so annexed.

SECTION 2. That said Plat of said "Parker's First Addition to the City of Crete, Nebraska" be and the same hereby is approved and accepted and the City Clerk hereby authorized and directed to so endorse the same, and thereupon said plat shall at once be filed and recorded in the office of the County Clerk of Saline County, Nebraska, together with a certified copy of this Ordinance, declaring such annexation, under the seal of said city, and proof of the due publication of this said ordinance; and thereupon such annexation of said territory so described in this ordinance shall be deemed complete, and said territory herein described and included in and described in said plat, shall be deemed, become, and be held to be, a part of the City of Crete, Nebraska, the corporate limits of said city extended to the limits of said territory, accordingly, and the inhabitants of such territory shall thereafter enjoy the privileges and benefits of such annexation, and be subject to the ordinances and regulations of said City of Crete, Nebraska; provided, such territory so annexed shall not be taxed for any indebtedness of the City of Crete, Nebraska, to which such territory is annexed, existing prior to the date of the completion of such annexation, all as provided in Section 17-405 Nebraska Revised Statutes Supplement, 1959;

SECTION 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
