ORDINANCE NO. 485

An Ordinance to annex, pursuant to and in accordance with the request of the sole owner, certain territory known as "Parker's Second Addition to the City of Crete, Nebraska", to said City, making findings of facts pertaining thereto, providing when this ordinance shall be in effect, and repealing all ordinances and parts of ordinances in conflict herewith.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CRETE, SALINE COUNTY, NEBRASKA:

SECTION 1. That said Mayor and Council hereby find and determine that the following described real estate, to-wit:

Beginning at a point Two Hundred Fourteen feet (214) North and One Thousand Twenty-seven (1027) feet East of the Northeast Corner of Lot One (1), Block Two Hundred Forty-three (243) in the Original City of Crete, Nebraska (which is 942.35 feet north and 33 feet West of the West 1/16 SW 1/4 S 35, T 8 N, R 4 E of the 6th P. M.); Thence North parallel to West line of Parker's First Addition, a distance of 483.86 feet; thence East parallel to the East line of 4th Street a distance of 343.52 ft. to the West line of Parker's First Addition; thence South along said West line a distance of 483.86 feet to the Northeast Corner of Lot 4, Block 2, Parker's First Addition; thence West along North line of said Lot 4 a distance of 343.52 feet back to the point of beginning;

lies contiguous to the corporate limits of said City of Crete, Nebraska, and has been by the act, authority and acquiescence of the sole owner thereof, subdivided into lots, containing not more than five acres each, and the whole thereof platted, duly made out, acknowledged, and certified, as required by law, into an addition named and designated as "Parker's Second Addition to the City of Crete, Nebraska", a copy of which Plat, duly certified, was on August 16th, 1966, filed in the office of the City Clerk of said City; that said territory should be annexed to the City of Crete, Nebraska, pursuant to and in accordance with the request of the sole owner of said territory, filed with said copy of said Plat, that said territory be so annexed;

SECTION 2. That said Plat of said "Parker's Second Addition to the City of Crete, Nebraska", be and the same is hereby approved and accepted and the City Clerk hereby authorized and directed to so endorse the same, and thereupon said plat shall at once be filed and recorded in the office of the County Clerk of Saline County, Nebraska, together with a certified copy of this Ordinance, declaring such annexation, under the seal of said City, and proof of the due publication of this said ordinance; and thereupon such annexation of said territory as described in this ordinance shall be deemed complete, and said territory herein described and
