Contract for Tree Trimming

This indenture made this 11th day of October 1924, by and between Nebraska Gas & Electric Co., a corporation (hereinafter called "Electric Company"), and Minnie B. Barber, of Lancaster Co County State of Nebraska (hereinafter called "Grantor").

WITNESSETH: THAT, WHEREAS, the Electric Company owns and operates an electric transmission line located on the East side of the highway West of Section 4, Township 10-N Range 7-E. County of Lancaster, State of Nebraska, and the

Grantor is the owner of the following described property. to-wit:

Lot 18 of irregular tracts, of Section 4 Township 10-N Range 7-E County of Lancaster State of Nebraska

Now, THEREFORE, for and in consideration of the covenants and agreements herein contained, the aforesaid Grantor does hereby grant unto the Electric Company, its lessees, successors and assigns, the perpetual right, privilege, easement and authority to enter upon and over the aforesaid described property and premises of Grantor, and the property of the Grantor adjoining thereto for tree trimming purposes and privileges and the perpetual right, privilege and authority, to cut down and to clear any and all trees located on Grantor's property aforesaid, near, contiguous to or adjoining the aforesaid transmission line, necessary to keep the said line or lines, wire or wires and equipment clear and unobstructed; and for said tree trimming and clearance purpose, the Electric Company shall have and hereby is given the perpetual right, privilege and authority to cut and clear any and all trees upon Grantor's property aforesaid, adjoining said electric transmission line for a distance and space of 50 feet, on the East side of said electric transmission line.

In consideration of said grant and easement aforesaid, Electric Company has this day paid the Grantor 150.00 One hundred & fifty & No/100 Dollars (\$150.00) in cash, the receipt of which said amount Grantor hereby acknowledges and which said amount shall be and constitute the entire compensation and consideration for the rights, privileges and easement hereby granted for all time to come.

As a part of aforesaid cash consideration, Grantor agrees free of cost and expense to Electric Company, to do and perform the following work, to-wit:

Grantor agrees to remove all trees and brush for a distance of fifty ft from said Electric line as described above.

This indenture made this 2nd day of October 1924, by and between Nebraska Gas & Electric Company, a corporation (hereinafter called "Electric Company") and Henry M. Worley; of Lancaster County State of Nebraska (hereinafter called "Grantor").

WITNESSETH: THAT, WHEREAS, the Electric Company owns and operates an electric transmission line located on the North side of the highway South of Section 15,
