

ASSIGNMENT OF EASEMENTS ETC. NEBRASKA PUBLIC POWER DISTRICT ET AL LOUP RIVER PUBLIC TO POWER DISTRICT

ASSIGNMENT OF EASEMENTS, FLOWAGE PERMITS, CONTRACTS, JOINT USE POLE AGREEMENTS, FRANCHISES, AGREEMENTS WITH MUNICIPALITIES, RAILROAD CROSSING AGREEMENTS, RAILWAY COMMISSION FRANCHISES, LEASES, MISCELLANEOUS AGREEMENTS AND RIGHTS

For value received and in performance of the terms and conditions of a Lease-Purchase Agreement of its Four-County Properties dated November 6, 1968, between Nebraska Public Power District, formerly Consumers Public Power District, a public corporation and political subdivision of the State of Nebraska, and Loup River Public Power District, a public corporation and political subdivision of the State of Nebraska, Nebraska Public Power District assigns all of its right, title and interest to Loup River Public Power District in and to all easements, flowage permits, contracts, joint use pole agreements, franchises, agreements with municipalities, railroad crossing agreements, railway commission franchises, leases, miscellaneous agreements and rights identified on the lists attached hereto as Attachments AI through AIV and BI through BXII, provided that in any case where an item identified on the Attachments cannot be assigned without consent, approval or agreement of a third party, this Assignment shall not become effective unless and until such necessary approval, consent or agreement is obtained and where an item identified on the Attachments covers facilities both inside and outside the Four-County Area of Platte, Boone, Nance and Colfax, only the part covering facilities in said Four-County Area is assigned.

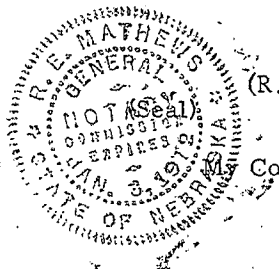

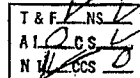
