A roadway easement described as follows, to wit:

A roadway easement 30 feet wide, commencing at the southeast corner of Lot 1, Block A, Randall 3rd Addition to the City of Columbus, Platte County, Nebraska and on the north right of way line of 23rd Street in said City; thence N 00 00'00" E a distance of 585.17 feet along the east line of said Lot 1 to the point or place of beginning;
