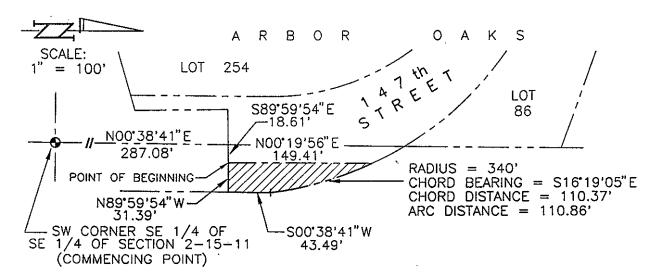

THAT PART OF THE SE 1/4 OF THE SE 1/4 OF SECTION 2, T15N, R11E OF THE 6TH P.M., DOUGLAS COUNTY, NEBRASKA, DESCRIBED AS FOLLOWS: COMMENCING AT THE SW CORNER OF THE SE 1/4 OF THE SE 1/4 OF SAID SECTION 2:

THENCE N00°38'41"E (ASSUMED BEARING) 287.08 FEET ON THE WEST LINE OF SAID SE 1/4 TO THE NORTH LINE OF WEST MAPLE ROAD;

THENCE S89°59'54"E 18.61 FEET ON THE NORTH LINE OF WEST MAPLE ROAD TO THE POINT OF BEGINNING, SAID POINT BEING ON THE WEST LINE OF A TRACT OF LAND DESCRIBED ON A WARRANTY DEED RECORDED IN BOOK 1957 AT PAGE 690 OF THE DOUGLAS COUNTY RECORDS AND HEREINAFTER CALLED TRACT "A";

THENCE N00°19'56"E 149.41 FEET ON THE WEST LINE OF SAID TRACT "A";
