THIS MEMORANDUM OF LEASE is made as of this 27 day of necessary, between Fantasy's, Inc., a Nebraska corporation, hereinafter referred to as "Landlord," and Heartland Automotive Services, Inc., a Minnesota corporation, hereinafter referred to as "Tenant".

Landlord has leased to Tenant the real property situated in the County of Douglas, State of Nebraska, as described in Exhibit "A" attached hereto and made a part hereof, pursuant to the terms of that certain Lease Agreement between Landlord and Tenant dated August 15, 2001 (the "Lease").
