

FIRST AMENDMENT TO DEED OF TRUST

THIS FIRST AMENDMENT TO DEED OF TRUST (this "First Amendment") is made this 30th day of September, 2011 (the "Effective Date") among GREAT WESTERN BANK, a bank chartered under the laws of the State of South Dakota ("Trustee", "Lender" and "Beneficiary"), and FANTASY'S, INC., a Nebraska corporation ("Trustor"), with respect to that certain Deed of Trust (as the same may be amended, restated, modified or supplemented from time to time, the "Deed of Trust") dated May 31, 2005, executed by Trustor to Trustee for the benefit of Beneficiary, which Deed of Trust was recorded January 19, 2007 as Instrument No. 2007007547 with the Douglas County, Nebraska Register of Deeds with respect to that certain real estate located in Douglas County, Nebraska, more particularly described in Exhibit A attached hereto and incorporated by reference herein.

WITNESSETH:

- 1. All terms used herein, unless specifically modified by this First Amendment, shall have the same meaning as ascribed to them in the Deed of Trust. Where the terms of this First Amendment may conflict with the terms of the Deed of Trust, this First Amendment shall control.
- 2. Beneficiary and Trustor hereby agree that this First Amendment is given in consideration of Beneficiary entering into that certain Forbearance Agreement and First Global Amendment (GWB Loans) dated on even date herewith among Trustor, Tranquility Realty, LLC, a Nebraska limited liability company, West Maple Fantasy's, LLC, a Nebraska limited liability company, and Beneficiary, and other good and valuable consideration, the receipt of which is hereby acknowledged.
- 3. Beneficiary and Trustor hereby agree that the Deed of Trust was intended to and did convey to Trustee in trust, WITH POWER OF SALE, for the benefit of Beneficiary, all of Trustor's right, title and interest in and to the "Lease" (as that term is defined below) in addition to all other property described in the Deed of Trust, and the term "Real Property" as described in the Lease includes Trustor's interest in, to and under the Lease. As used herein, the word "Lease" means the lease of property dated April 20, 2000, between Robert J. Krejci, Gail D. Krejci and F & J Enterprises, Inc., collectively as Landlord, and Trustor as Tenant, which Lease was recorded with the Douglas County Register of Deeds on August 17, 2000 at Misc. Book 1348, Page 332.
- 4. Except as specifically amended herein, the Deed of Trust shall remain in full force and effect as originally executed.
- 5. This First Amendment shall be binding on the successors and assigns of the parties hereto.
