

The electric line (s) to be located as follows: SEE ATTACHED EXHIBIT "A" WHICH IS HEREBY MADE A PART HEREOF.
The grantor also grants the Omaha Public Power District power to extend to the Telephone Company the right to use jointly with the Omaha Public Power District any pole placed parsuant to the provisions hereof. The foregoing right is granted upon the express condition that the Omaha Public Power District and Plassume liability for all damages to the above described property caused by said District's failure to use due care in its exercise of the granted high.
