01 AN ORDINANCE vacating Starr Street from the west line of North 50th Street west
02 approximately 237 feet and east-west and north-south alleys within Block 2, Cones Subdivision,
03 being between 48th, 50th, Dudley, and Starr Streets, Lincoln, Lancaster County, Nebraska.

04 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

05 Section 1. That Starr Street from the west line of North 50th Street west approxi-
06 mately 237 feet be and the same is hereby vacated, subject to the title of said Starr Street being
07 vacated remaining in the City of Lincoln, Lancaster County, Nebraska.

08 Section 2. That all of the east-west and north-south alleys within Block 2, Cones
09 Subdivision, being between 48th, 50th, Dudley and Starr Streets, Lincoln, Lancaster County,
10 Nebraska, be and the same are hereby vacated, subject to title remaining in the City of Lincoln.

11 Section 3. That this ordinance shall take effect and be in force from and after its
12 passage and publication according to law.

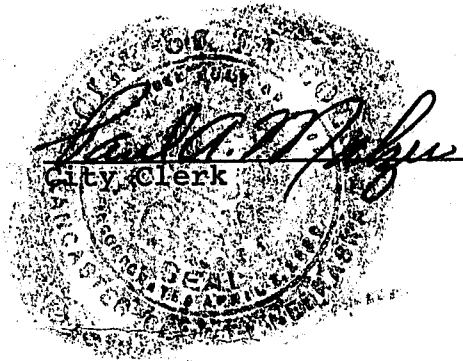
