## RESOLUTION

WHEREAS, the public road in Dixon County, Nebraska, described as follows:

The North and South public road which lies between Sections 15 and 16 and between Sections 21 and 22, Township 29 North, Range 4, East of the 6th P.M., in Dixon County, Nebraska;

has heretofore been designated and established as a Dixon County public road pursuant to Sections 39-2001 to 39-2003, Revised Statutes of Nebraska for 1943, as amended; and

WHEREAS, the Board of Supervisors of Dixon County, Nebraska, now, for good and sufficient reasons, desires to detach said public road from the Dixon County road system and cause the same to revert back to Clark Township as a township public road, so that said County Board and said Dixon County will no longer be obligated to maintain the same, and hereafter the maintenance and improvement of said road will devolve and rest upon said Clark Township of Dixon County, Nebraska, as a township public road; as provided by said Section 39-2003 and Section 39-1727, of said Nebraska Statutes for 1943, as amended. NOW THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of Dixon County, Nebraska, as follows:

That the public road in Dixon County, Nebraska, described as follows:

The North and South public road which lies between Sections 15 and 16 and between Sections 21 and 22, Township 29 North, Range 4. East of the 6th P.M., in Dixon County, Nebraska;

which has heretofore been designated, established, and maintained as a Dixon County public road and as a part of the Dixon County public road system, be and hereby is detached from said Dixon County public road system and as of the date of this resolution the same shall forthwith revert back to and become a township public road of Clark Township, in said Dixon County, Nebraska; and from this date said Dixon County is no longer obligated to maintain and improve said public road and, as provided by law, the maintenance and improvement thereof shall devolve upon and be in said Clark Township of Dixon County, Nebraska; all being pursuant to said statutes of Nebraska pertaining thereto.
