GRANT OF EASEMENT AND MEMORANDUM OF AGREEMENT

Cox owns and/or Grantor has granted to Cox the exclusive right to use all or a portion of the Facilities. Any Facilities owned by Cox shall not be deemed a fixture of the Property.

Grantor may grant other easements, servitudes, or rights of access to the Property and use the Property for any purpose that does not restrict or interfere with Cox's use of the Facilities pursuant to this Easement, does not damage the Facilities, and is consistent with Cox's rights under either this Easement or the Agreement (as such term is defined below).

PLEASE TAKE NOTICE that, contemporaneously with this Easement, Grantor and Cox have also entered into that certain Service Agreement, dated 8/2/2017, as such may be amended, extended, renewed or replaced (collectively, the "Agreement") which may contain additional information regarding the Facilities and the Services.
