Affidavit regarding Amendment to Restrictive Covenants

The undersigned affiant, being first duly sworn upon oath, hereby states, with respect to the property legally described on the attached Exhibit "A" (herein, the "Property").

- 1. I am the attorney for the "Owners" identified in Restrictive Covenants filed as Inst. No. 2000-038888, amended by Amendment No. 1 to Restrictive Covenants filed as Inst. No. 2001-032738, Amendment No. 2 filed as Inst. No. 2014039554, all with the Lancaster County Register of Deeds (herein, "Covenants"), being South Industrial Park LLC and Assurity Life Insurance Company f/k/a Security Financial Life Insurance Co.
- 2. The Covenants were amended by **deleting** the existing Section 7 13 and **replacing** it with the following new Section 7.13 (the "Amendment"):
 - 7.13 <u>SETBACKS</u>: The buildings of all Lot Owners, at a minimum, must (i) comply with the setback requirements of the I-3 (Employment Center District) zoning district and the Use Permit in effect at the time of issuance of a building permit, and (ii) be located outside of the flood plain.
- 3. There are presently 22 Lots within the Property, and the approval of at least 15 Lot Owners was necessary in order to amend the Covenants pursuant to Section 10 1 of the Covenants.
- 4. The Amendment was approved in writing by 15 Lot Owners. Accordingly, the Amendment to the Covenants was duly adopted
